
ORDER NO. **505**-SSB of 2018
DATED **31**.12. 2018.

Sub:- Cancellation of candidature of candidates for the post of "**Accounts Assistant**" (Finance Department) District Cadre Anantnag, pursuant to advertisement Notification No. 07 of 2010 item No. 391.

Reference: Decision of **146th** meeting of Board of JKSSB.

- 1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Accounts Assistant**" (Finance Department) District Cadre Anantnag, pursuant to advertisement Notification No. 07 of 2010 item No. 391 and recommended the same to the Finance Department vide letter No.SSB/ Secy/ Sel/2018/809-15 dated 17.01.2018; and
- 2/ Whereas, the recommendation in respect of one candidate namely **Azhar Ahmad Rather S/o Mohd Yousuf Rather figuring at S.No.13 under open merit** was kept withheld and was subject to genuineness and production of bonafide certificate of Graduation and Post Graduation and clarification with regard to validity and equivalence of PG which was to be furnished within 30 days but he did not furnish the same; and
- 3/ Whereas, the said candidate was served a notice vide this office No. SSB/Secy/Sel/AA/Ang/2018/10916-19 dated 13.11.2018 again asking him to furnish the requisite document within 07 days from the date of issuance of the said notice failing which the selection/recommendation against shall be cancelled without further notices. The candidate again did not furnish the same; and
- 4/ Whereas, in response to the aforementioned notice, the candidate has submitted an undertaking in the shape of an affidavit duly attested by Judicial Magistrate Ist Class, Vailoo stating therein that he is not interested in joining against the said post; and
- 5/ Whereas, the matter was considered by the Board in its **146th** meeting wherein it was decided that the candidature/selection of the above said candidate be cancelled so that the deserving candidate against the post of Accounts Assistant in the waiting list get a chance of employment.

7/ Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Azhar Ahmad Rather S/o Mohd Yousuf Rather figuring at S.No.13 under open merit** for the post of **"Accounts Assistant"** (Finance Department) District Cadre Anantnag, pursuant to advertisement Notification No. 07 of 2010 item No. 391 is cancelled/ withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required.
