Subject: - SWP No. 2468/2018, IA No. 01/2018 titled Sudhir Singh Rana V/S State of Jammu and Kashmir and others-Conduct of Interview and Counselling cum Document Verification pursuant to Court orders.

1. Whereas, the writ petition bearing SWP No. 2468/2018, IA No. 01/2018 titled Sudhir Singh Rana V/S State of Jammu and Kashmir and others came to be filed before the Hon'ble High Court of J&K at Jammu.
2. Whereas, the Hon'ble High Court while considering the above referred writ petition on 14.12.2018 was pleased to direct that in the meanwhile, subject to objections and till next date before the bench, respondents are directed to conduct the interview of the petitioner for the post of Naib Tehsildar, however, this shall not confer any right of selection on the petitioner. It was further directed that the result of the interview shall not declared till further orders of the Hon'ble Court.
3. Whereas, the Jammu and Kashmir Services Selection Board is in the process of filing of detailed objections/application for vacation of interim directions before the Hon'ble Court.
4. Whereas, the matter was considered by the Board in an extraordinary meeting held on 03.01.2019 and it was decided that pending consideration of the writ petition and till further orders of the Hon'ble Court, the petitioner may be called for interview/document verification in due deference to order dated 14.12.2018 passed by the Hon'ble Court. However, his participation in the interview shall be purely provisional and subject to consideration of objections to be filed by the Board before the Hon'ble Court and outcome of the writ petition.

Now therefore, it is notified for the information of the below mentioned candidate/petitioner that the interview for the post of Naib Tehsildar pursuant to advertisement notification No. 01 of 2015 shall be conducted on 12th of January, 2019 at Central Office, SSB, Sehkar Bhawan Rail Head Complex Jammu at 10:00 AM.
