Subject: - SWP No. 2418/2018, IA No. 01/2018 titled Mansoor Nazir V/S Chairman Services Selection Board and another- conduct of Interview and Counselling cum Document Verification pursuant to orders of Hon'ble Court.

1. Whereas, the writ petition bearing SWP No. 2418/2018, IA No. 01/2018 titled Mansoor Nazir V/S Chairman Services Selection Board and another came to be filed before the Hon'ble High Court of J&K at Srinagar.
2. Whereas, the Hon'ble High Court while considering the above referred writ petition, on 15.10.2018 was pleased to direct that in the meantime, subject to objections and till next date before the Bench, the petitioner in the event having obtained 89 points or more shall be allowed to compete the process of selection result whereof shall not be disclosed unless further orders.
3. Whereas, the Jammu and Kashmir Services Selection Board filed a detailed reply in opposition to the averments of the writ petition filed by the petitioner, as also an application for vacation/modification of order dated 15.10.2018 before the Hon'ble High Court.
4. Whereas, the writ petition/application filed by the Board before the Hon'ble Court has not been considered as on date.
5. Whereas, the matter was considered by the Board in an extraordinary meeting held on 03.01.2019 and it was decided that pending consideration of the objections filed by the Board in the matter and further orders of the Hon'ble Court, the petitioner may be called for interview/document verification in due deference to order dated 15.10.2018 passed by the Hon'ble Court. However, his participation in the interview shall be purely provisional and subject to consideration of objections filed by the Board before the Hon'ble Court and outcome of the writ petition.

Now therefore, it is notified for the information of the below mentioned candidate/petitioner that the interview for the post of Naib Tehsildar pursuant to advertisement notification No. 01 of 2015 shall be conducted on 12th of January, 2019 at Central Office, SSB, Sehkari Bhawan Rail Head Complex Jammu at 10:00 AM.
