



Sub:- Cancellation of Selection list of candidates for the post of "**Survey Cum Excavation Assistant**" (Culture Department), item No.204 Notification No. 05 of 2015 Dated 01.09.2015.

- 1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Survey Cum Excavation Assistant**" (Culture Department), item No.204 Notification No. 05 of 2015 Dated 01.09.2015 and recommended the same to the Culture Department vide letter No. SSB/ Secy/ Sel/ 2018/8545-52 dated 24.07.2018 for further course of action; and
- 2/ Whereas, the selection of one candidate namely **Abid Mustafa Dar S/o Mohd Sultan Dar figuring at S.No.01 under OM category** has been kept withheld and is subject to relevance of qualification ; and
- 3/ Whereas, the matter with regard to equivalence of qualification was taken up with Culture Department, Civil Secretariat, Jammu vide this office letter No. SSB/Sel/Secy/178/18/11127 dated 20.11.2018 with the request to clarify whether the **M.A (History)** can be considered for the post under reference for which prescribed qualification as per indent **M.A Archeology/Ancient History** or otherwise ; and
- 4/ Whereas, in response, the Culture Department, Civil Secretariat, Jammu vide letter No. Cul/Gen/63/2013-II dated 22.11.2018 requested the Board to furnish recommendations strictly as per indent referred vide their Department's letter dated 14.08.2015 wherein the prescribed qualification was given as "M.A Archaeology/ Ancient History" for the post under reference; and
- 5/ Whereas, the case has been re-examined in light of the opinion furnished by the indenting department and accordingly it was decided in the Board that the selection of the candidate namely **Abid Mustafa Dar S/o Mohd Sultan Dar figuring at S.No.01 under OM category** possessing M.A (History) shall be cancelled.
- 6/ In the backdrop of the situation narrated herein above, the withheld selection of **Abid Mustafa Dar S/o Mohd Sultan Dar figuring at S.No.01 under OM category** is cancelled/withdrawn abinitio and the indenting department is requested to operate the waiting list if required.
