Sub:- Cancellation of Selection list of candidates for the post of "Teacher " (Education Department) District Cadre Srinagar, item No.037 (01 of 2012 dated 19.07.2012) under Hon'ble Prime Ministers Special package for Kashmir migrants (pending posts).

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Teacher " (Education Department) District Cadre Srinagar, item No.037 (01 of 2012 dated 19.07.2012) under Hon'ble Prime Ministers Special package for Kashmir migrants (pending posts) and recommended the same to the Revenue Department vide letter No. SSB/Secy/Sel/2017/11258-65 dated 06.11.2017 for further course of action; and


2/ Whereas, amongst others, the selection of one candidate namely **Vishal Zadoo S/o Veer Ji Zadoo figuring at S.No.20-Waiting under OM category** has been kept withheld and is subject to clarification with regard to equivalence of 10+2 & Graduation and validity of Graduation, recognition of the Institute and production of bonafide certificate thereof ; and

3/ Whereas, the matter with regard to equivalence/recognition status was taken up with Secretary J&K State Board of School Education, Jammu vide this office letter No. SSB/Sel/Secy/Tr/Sgr/XVIII/3320 dated 27.03.2018 with the request to clarify whether the qualification inter (10+2) acquired by the candidate in the year 2007 from **Bhartiya Shiksha Parishad, Uttar Pradesh** is equivalent/recognized or otherwise ; and

4/ Whereas, in response, the J&K State Board of School Education conveyed that **Bhartiya Shiksha Parishad, Uttar Pradesh** does not appear in the list of recognized Boards of School Education, therefore, the certificate issued by **Bhartiya Shiksha Parishad, Uttar Pradesh** can not be granted equivalence by the JK Board and that the J&K State Board of School Education grants equivalence to all such type of Examination which have been recognized by the Central Boards of Secondary Education (CBSE) New Delhi/Association of Indian Universities (AIU) New Delhi and other Govt. recognized Board of the country on the basis of reciprocity; and

5/ Whereas, the case has been re-examined and accordingly it was decided that the selection of the aforementioned candidate shall be cancelled.

In the backdrop of the situation narrated herein above, the withheld selection of **Vishal Zadoo S/o Veer Ji Zadoo figuring at S.No.20-Waiting under OM category** is cancelled/withdrawn abinitio.
