
1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Teacher**" (Education Department) District Cadre Srinagar, item No.037 (01 of 2012 dated 19.07.2012) under Hon'ble Prime Ministers Special package for Kashmir migrants (pending posts) and recommended the same to the Revenue Department vide letter No. SSB/Secy/Sel/2017/11258-65 dated 06.11.2017 for further course of action; and

2/ Whereas, amongst others, the recommendation of one candidate namely **Manish Safaya S/o Puran Krishan Safaya figuring at S.No.49-Waiting under OM category with total merit 36.6667** has been kept withheld and is subject to clarification with regard to validity of Graduation and production of bonafide certificate thereof; and

3/ Whereas, the candidate furnished an affidavit/representation that the two additional points given to him for his Graduation Degree may be deducted and his withheld recommendation be released. The case was processed in the Board and it was decided that 02 points given to Graduation qualification shall be deducted from overall merit of the candidate; and

4/ Whereas, after deducting (02) points from over all merit of the candidate, the candidate will now figure at S.No.57-Waiting under OM category with revised merit position **34.6667 points**. Consequently the candidate earlier figuring at S.No.50 under OM category shall now figure at S.No.49 under OM category, S.No. 51 shall now figure S.No. 50, S.No. 52 shall now figure S.No. 51, S.No. 53 shall now figure S.No. 52, S.No. 54 shall now figure S.No. 53, S.No. 55 shall now figure S.No. 54, S.No. 56 shall now figure S.No. 55 and S.No.57 shall now figure S.No.56.

In view of the situation enumerated herein above, the recommendation of the candidate namely **Manish Safaya S/o Puran Krishan Safaya** is hereby released at S.No. 57-Waiting under OM category as per terms and conditions already conveyed vide this office letter No. SSB/Secy/Sel/2 017/11258-65 dated 06.11.2017.
