Subject:- Issue of change of categories.

Order No. 48 –SSB of 2019  
Dated. 21 .02.2019

Whereas, while filling the details in the application form, terms and conditions of the advertisement are notified and the candidates are advised to fill the details/particulars in the online application forms carefully as same are treated as final.

2. Whereas, some candidates have sought change of the categories, they have mentioned in their online application forms, when the Board has no role in filling of particulars of candidates, including categories they belong to, as such details are to be filled up in the online application forms by the candidates themselves.

3. Whereas, the Board in light of decisions already taken in its 73<sup>rd</sup> meeting, has been taking a consistent stand to reject such claims of the candidates and instead treat all such candidates, who fill their reserve category status wrongly, as General category candidates.

4. Whereas, entertaining such requests at this stage would affect the shortlist of categories already notified and would also be a departure from the consistent stand, the Board has taken in such issues in the past.

5. Whereas, in a related matter about disposing off the claims, the General Administration Department vide its communication No.GAD/Mtg/RB-IV/53/2018 dated 16.11.2018, intimated that the issue has been examined in consultation with the Department of Law, Justice and Parliamentary Affairs and also conveyed the following advice of the Learned Advocate General for further appropriate of action, which, inter-alia, reads as under:-

*"...Finally, the Full Bench (in case titled "Competent Authority Entrance Examination, J&K, Jammu and Anr V/S Mahesh Kumar Raina & Anr.") has laid down the following proposition of law:-*

*A candidate must possess the eligibility on the cutoff date and if he/she claims that he/she belongs to a particular category in the application form and unable to produce the proof/certificate before the cutoff date inspite of his/her best efforts the said candidate shall be permitted to produce the*

*proof before finalization of the selection for admission/ appointment as producing proof is procedural and if no claim is made in the application, the candidate cannot be permitted to produce proof of the same and such candidate shall be considered in open merit category.*

*In the present case, there is a failure to produce the proof of higher qualification before the cutoff date, as such, the rigour of eligibility becomes more strict. The record further reveals that in the instant case, the candidates have raised the issue of higher qualification after selection process, therefore, the relaxation of the eligibility conditions may not be in tune with the law as it holds its field as on date. However, it needs to be examined as to whether any candidate who have indicated in the application form the factum of possession of higher qualification, but later on failed to produce the same at the relevant point of time can be considered for such relaxation as an exception.*

*In all such cases where the Hon'ble Court has granted interim relief, the judgement of the Full Bench be brought to the notice of the Hon'ble Court and where writ petitions have been finally disposed off, the matter can be agitated by way of appeal(s) before the concerned Bench(s)."*

6. Whereas, the Board in its 147<sup>th</sup> meeting decided to align the selections strictly as per above laid down law and the stand taken by the Board in its 73<sup>rd</sup> meeting.

Now, therefore, keeping in view the above, the claims of the candidates are disposed off as per annexure to this order.
