Subject:- Issue of unmentioned degrees in online application form.

Order No. 50-SSB of 2019
Dated. 21 .02.2019

Whereas, the Jammu & Kashmir Services Selection Board had invited online applications from eligible candidates for District cadre posts of Teachers vide Notification No.06/2017/01 to 06/2017/14 dated 28.12.2017 (General Line) No.06/2017/15 to 06/2017/28 dated 28.12.2017 (Math/Science) and No.06/2017/29 to 06/2017/42 dated 28.12.2017 (Urdu). Following criteria was adopted by the Board for awarding points for additional qualifications: -

B.Ed	= 05 Marks
M.Ed	= 05 Marks
PG	= 02 Marks
M.Phil	= 01 Marks
Ph.D after M.Phil	= 02 Marks
Direct Ph.D	= 03 Marks
Total	= <u>15 Marks</u>
Written Test	= <u>85 Marks</u>
Grand Total	= <u>100 Marks.</u>

2. Whereas, it was stipulated in Paragraph-3 of Annexure-B of the advertisement notification(s) that: -

".....Only those candidates will get preference points who have entered the requisite qualifications in their form (by entering it in their profile before). If the same is not reflected in form, no points will be allocated, even if the candidates produce any such degree at a later stage."

3. Whereas, despite afore-stated condition contained in the advertisement notification, some candidates have failed to mention their B.Ed/M.Ed/PG and other qualifications in the qualification details of online application forms, as such, were not awarded preferential points during result generation and preparation of shortlist.

4. Whereas, the data with regard to eligibility for entitlement of preferential points on the basis of their qualification was taken, on the basis of details recorded by the candidates under specific qualification details in the online application forms and such data has been made basis for generating the result and notifying the shortlist.

5. Whereas, subsequently, the candidates who had failed to mention their degrees in the relevant part of online application form, approached the Hon'ble Court and obtained orders of the Hon'ble Court and many candidates made representations to the Board, seeking allocation of weightage in respect of their skipped qualifications. However, a few candidates also represented that the Board has not given preferential points for the qualifications, entitled for such weightage, though they have recorded such details of qualifications in their online application forms.

6. Whereas, having regard to the unambiguous import of the paragraph-3 of Annexure-B of the advertisement notification as also keeping in view the fact that the acceptance of the claim of the said candidates/writ petitioners, has bearing to exclude other candidates who figure in the shortlist and eventually resulting not only into multiple litigations but also unprecedented administrative difficulties including delay in finalization of selection lists, the representation(s) filed by the candidates and orders of the Hon'ble Court received in some writ petitions, the issue was taken up with the General Administration Department vide communication No.SSB/Legal/8888 dated 25.07.2018, for advice and decision in the matter in consultation with the Department of Law, Justice and Parliamentary Affairs, so that representations are disposed off and stand is taken in the court cases, accordingly.

7. Whereas, the General Administration Department vide its communication No.GAD/Mtg/RB-IV/53/2018 dated 16.11.2018, intimated that the issue has been examined in consultation with the Department of Law, Justice and Parliamentary Affairs and also conveyed the following advice of the Learned Advocate General for further appropriate of action, which, inter-alia, reads as under:-

"...Finally, the Full Bench (in case titled "Competent Authority Entrance Examination, J&K, Jammu and Anr V/S Mahesh Kumar Raina & Anr.") has laid down the following proposition of law:-

A candidate must possess the eligibility on the cutoff date and if he claims that he/she belongs to a particular

category in the application form and unable to produce the proof/certificate before the cutoff date inspite of his/her best efforts the said candidate shall be permitted to produce the proof before finalization of the selection for admission/ appointment as producing proof is procedural and if no claim is made in the application, the candidate cannot be permitted to produce proof of the same and such candidate shall be considered in open merit category.

In the present case, there is a failure to produce the proof of higher qualification before the cutoff date, as such, the rigour of eligibility becomes more strict. The record further reveals that in the instant case, the candidates have raised the issue of higher qualification after selection process, therefore, the relaxation of the eligibility conditions may not be in tune with the law as it holds its field as on date. However, it needs to be examined as to whether any candidate who have indicated in the application form the factum of possession of higher qualification, but later on failed to produce the same at the relevant point of time can be considered for such relaxation as an exception.

In all such cases where the Hon'ble Court has granted interim relief, the judgement of the Full Bench be brought to the notice of the Hon'ble Court and where writ petitions have been finally disposed off, the matter can be agitated by way of appeal(s) before the concerned Bench(s)."

8. Whereas, in view of the above, the claims of the candidates for award of preferential points for unmentioned qualifications for the posts of Teacher, shall have to be considered, accordingly, keeping in view the fact that the candidates have failed to mention their qualification in the qualification details in their online application form, when it was made explicit in the Advertisement notification that only such candidates could be considered for preferential points, who have entered requisite qualification in their online application forms, and the law laid down on the subject as per advice of the Learned Advocate General forwarded by the General Administration Department.

Now, therefore, the claims of the candidates who failed to mention their qualifications in the specific qualification details of

the online application forms, which has also been established during document verification process, are not tenable. However, in respect of candidates who have claimed that they have entered such qualification in their online application forms, but SSB has skipped to take note of such degrees during massive data generation of 250620 candidates, the necessary rectification shall be carried out and admissible preference points strictly as per qualification, shall be allocated subject to the following conditions: -

1. That they have indicated all such degrees in qualification details of the online application forms, and nothing contrary has been established by the Convenor of the Document Verification Committee.
2. The degree has been obtained prior to cut off date in the advertisement.

Further, the mention of qualification if any, made elsewhere and not in the specific qualification details in the online application form, which have been used for generation of data across the board for declaration of the shortlists, shall not be considered, unless it is mentioned with all the desired information in the specific qualification details part of the online application form.

The claims and representations of the candidates figuring in the annexure to this order, are disposed off, accordingly.
