
Subject:- Revised selection list in respect of SC category for the post of FMPHW/ANM, Department of Health & Medical Education Department, Item No.031, District Cadre Jammu.

Whereas, The Board in pursuance of an indent received from Health & Medical Education department vide No: HD/FW/27/2015 dated: 18.04.2017 issued an Advertisement Notification for the said post in terms of Advertisement No.01 of 2017 dated: 20.07.2017 under Item No.031 and the final selection list came to be approved by 141st Board meeting and the same was forwarded to the Indenting Department vide Communication No.SSB/Secy/Sel/2018/10368-74 dated:09-10-2018;and

Whereas, thereafter, the examination of a representation submitted by a candidate in this regard revealed that on account of an inadvertent error the representee candidate has been left out of the SC Category selection list, despite the fact that she had secured higher merit than the candidate figuring on the last serial of the SC category and the wait list under SC category and OM category; and

Whereas, perusal of the record, in this regard, revealed that the said candidate (Nancy Bharti) has indeed got a score of 31.1667 whereas the score of the candidate figuring at the last serial of SC category list is 30.8333 only and the score of the candidate figuring in wait list SC category and wait list OM Category is 30.8333 only and the matter was placed in the Board of JKSSB for discussion and decision thereof, wherein it was decided that the select list for the post under reference be modified appropriately, strictly in order of merit.

Now, therefore, in background of the situation so narrated herein above, it is hereby ordered that Nancy Bharti who figured in Provisional select list as S.No 1 in SC category shall now be S.No. 1 in SC Final Select list. Rimphy Devi who figured in the final select list as S.No 1 in SC category shall now be S. No.1 in SC category Wait list and S. no. 2 in OM wait List in Final Select list. And, Candidate namely Raji Bala who figured at S.No 1 SC Wait list and S. no.2 OM wait list shall now be dropped from the final select list. The revised merit position of the Select list/wait list under SC and OM category, thus is given as Annexure 'A' to this order.
