
Whereas, the Board in pursuance of an indent received from Department of Disaster Management, Relief, Rehabilitation & Reconstruction vide No: DMRRR/MR/140/2017 Dated:- 23-10-2017 issued an Advertisement Notification for the said posts in terms of Advertisement No.04 of 2017 dated:01.12.2017 under Item No.07 and the final selection list came to be approved by 149<sup>st</sup> Board meeting and was uploaded on the official website of the JKSSB;and

Whereas, thereafter, the examination of a representation submitted by a candidate in this regard revealed that on account of an inadvertent error, the representee candidate has been left out of the RBA Category selection list, despite the fact that he resides in Kashmir division and falls under SRO 425 as Non-Migrant Kashmiri Pandit; and

Whereas, as decided in the meeting presided over by the Commissioner/ Secretary DMRRR held on 23-02-2019, the selection of the candidate was to be considered as the candidate was a non-migrant Kashmiri Pandit and the matter was placed in the 150<sup>th</sup> Board meeting for discussion and decision and it was decided that the candidate on account of his merit and category shall figure at S.No 2 of the select list in the RBA Category.

Now, therefore, in background of the situation so narrated herein above, it is hereby ordered that **Sahil Bhat** whose selection was deferred earlier due to an inadvertent error shall now be S.No. 2 in RBA final select list. The merit position of the candidate in the select list under RBA category, is thus given as Annexure 'A' to this order and shall be forwarded to your department along with the main select list, which shall be revised accordingly.
