Sub:- Selection list of candidates for the post of "**Accounts Assistant**" (Finance Department) District Cadres Kupwara pursuant to advertisement Notification No. 07 of 2010 against item No.397.

Reference: Decision of 151st of meeting of Board of JKSSB.

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Accounts Assistant**" (Finance Department) District Cadres Kupwara pursuant to advertisement Notification No. 07 of 2010 against item No. 397 and recommended the same to the Finance Department vide letter No.SSB/ Secy/ Sel/ 2018/809-15 dated ~~17.01.2018~~ for further course of action; and

2/ Whereas, amongst others, the recommendation of one candidate namely **Mohd Amin Lone S/o Gh Mohiuddin Lone figuring at S.No.30 under OM/HCL category** has been kept withheld and is subject to clarification with regard to equivalence of Graduation and recognition of institute issuing Graduation and production of bonafide certificate thereof and clarification with regard to date of declaration of PG result; and

3/ The matter with regard to equivalence of Graduation was taken up with Kashmir University vide this office letter No. SSB/Secy/Sel/AA/Kup/18/7542 dated 27.06.2018 and No. SSB/Secy/Sel/AA/kup/18/9796 dated 07.09.2018 with the request to intimate whether B.A (Fazil Degree) from Jamia Dinyat Devbund (U.P) can be treated as equivalent to academic Graduation or otherwise; and


4/ Whereas, in response to the aforementioned communication, the Deputy Registrar Academic vide No. F(Clarification-Fazil)Acad/KU/18 dated 29.10.2018 has intimated that the candidates having passed their OC&MIL (oriental Classical Language or Modern India Language) examination from a recognized University/Body prior to July 2007 were required to pass General English and English Literature subjects of B.A Standard to consider the degree as equivalent to B.A degree of their University. Further such candidates were also required to pass one paper/subject from the humanities group of subjects other than General English and Urdu for pursuit of higher studies. However the condition has been relaxed and such candidates as would have passed the said examination from

2007 onwards are required to pass only General English subject of their University;
and

5/ Whereas, from perusal of the documents submitted by the candidate under reference, it has been found that the candidate has not passed General English and English Literature subjects of B.A Standard; and

6/ Whereas, the case was processed in the Board and it was decided that the candidate is not eligible for the post of Accounts Assistant.

In the backdrop of the situation so narrated herein above, the withheld selection of namely Mohd Amin Lone S/o Gh Mohiuddin Lone figuring at S.No.30 under OM/HCL category for the post of "Accounts Assistant" (Finance Department) District Cadre Kupwara pursuant to advertisement Notification No. 07 of 2010 against item No.397 is cancelled/withdrawn abinitio.
