
Whereas, the Board in pursuance of an indent received from Department of Disaster Management, Relief, Rehabilitation & Reconstruction vide No: DMRRR/MR/140/2017 Dated:- 23-10-2017 issued an advertisement notification for the various posts in terms of Advertisement No.04 of 2017 dated:01.12.2017. The Selection list in respect of Item No's. 144,147 and 148 came to be approved by Board in its 150th Board meeting and was uploaded on the official website of JKSSB; and

Whereas, before the selection list could be forwarded to the Indenting department, the Board received complaints from the some quarters that various RBA candidates who were provisionally selected under OM category have submitted both Migrant certificate issued by the Relief and Rehabilitation Commissioner (Migrants) Jammu and RBA certificate issued by the concerned Tehsildars of their Tehsils in Kashmir division to the Board for finalization of their selections. It was contended as to how a candidate living in backward area in Kashmir province is eligible for getting RBA certificate from the concerned Tehsildar and migrant certificate from the RRCM at the same time and become eligible under SRO-412 for the post under Hon'ble PM special package; and

Whereas, in view of above, Board had decided to keep recommendations withheld in case of above mentioned three candidates namely Rukhsana Bano (RBA) figuring at S.No 1(under OM Category) in Select list of Patwari , District Kupwara under item No.144, Suheeb Ahmad Mantoo(RBA) figuring at S.No 1(under OM Category) in Select list of Patwari, District Kulgam under item No.147 and Najlah Hamid(RBA) figuring at S.No 5 (Under OM Category) in Select list of Patwari, District Anantnag under item No.148 of Advertisement notification no. 04 of 2017 till verification of their PRC's, Migrant status viz-a-viz category certificate by the concerned DC through RRCM.


