NOTICE

Subject:- Selection list for the post of Quality Control Inspector (Industries & Commerce Department), Divisional Cadre Kashmir, Item No. 256(01 of 2011).

Whereas, the Board in pursuance of an indent received from Industries & Commerce Department vide No: IND/DOH/34/2008, Dated:- 25-01-2011 issued an Advertisement for the said posts in terms of Advertisement No.01 of 2011 dated: 31-01-2011 under Item No.256; and

Whereas, the qualification advertised for the post was "Degree in Handloom Textile Technology/ Wool Technology with 3 years diploma in Handloom/ Wool/ Wood Technology from recognized Institute or Commerce/ Economics / Law Graduate"; and

Whereas, during the Counseling / Document verification process it came to fore that the following 5 shortlisted candidates namely Imtiyaz Ahmad Dar, Tanveer Mohammad Ganai, Tahmeena Shafi, Zahoor Ahmad Khan and Javaid Ahmed Baigh are having 3 years Diploma in Handloom Technology / Wood Technology; and

Whereas, it was felt appropriate that a clarification in respect of the aforementioned candidates with regard to the relevance of their qualification viz-a-viz the prescribed qualification be sought from the indenting department; and

Whereas, vide this office letter No. SSB/Sel/Secy/2018/11414-15, dated 11-12-2018 the matter was taken up with the Industries & Commerce Department for the purpose, which in turn vide letter No. IND/DOH/34/2008-I, dated 28-02-2019 conveyed that:-

"Degree in Handloom Textile Technology/Wool Technology or Commerce/ Economics/ Law Graduate" are eligible for the post of Quality Control Inspector. Besides, in case of diploma holders who possess' Diploma in Handloom / Wool / Wood Technology from recognized Institute and later on obtain requisite "degree in Handloom Textile Technology" through lateral entry are also eligible"

Whereas, the matter was placed before the Board in its 153rd Board Meeting held on 21-05-2019 for discussion/decision thereof, wherein it was decided that the aforementioned five shortlisted candidates for the post of Quality Control Inspector advertised No. 01 of 2011, Item No. 256 are not eligible for the said post as they do not possess the prescribed qualification.

Now therefore, in light of the facts and circumstances so narrated herein above the candidates namely Imtiyaz Ahmad Dar, Tanveer Mohammad Ganai, Tahmeena Shafi, Zahoor Ahmad Khan and Javaid Ahmed Baigh are declared not eligible for the said post. Selection list of the eligible candidates thus is enclosed as Annexure "A" of this notice.
