Subject- Revised/Final Answer Key of the OMR Based Objective Type Written Examination for the posts of Driver, Divisional Cadre Jammu/Kashmir, Advertisement Notification Nos 01/2019/040, 02/2019/040, 03/2019/040 04/2019/040 and 05/2019/040 at Jammu and Srinagar on 26th of May, 2019(Sunday) after disposal of the representations- regarding.

1. Whereas, the J&K Services Selection Board conducted written examination for the posts of Driver, Divisional Cadre Jammu/Kashmir, Advertisement Notification Nos 01/2019/040, 02/2019/040, 03/2019/040 04/2019/040 and 05/2019/040 at Jammu and Srinagar on 26th of May, 2019(Sunday); and
2. Whereas, a link was activated on the official website of Board, subsequently, for sharing the Answer Keys of different sets along with the provision of submitting representations, if any, against the key, regarding the correctness of the key;
3. Whereas, a total of 31 unique representations were received within the stipulated time in respect of the above mentioned exam. Upon examination of the representations by the experts, it has been found that there is only one question where two answering options are correct and one question needs to be nullified in comparison to the declared Answer Key. The resultant changes in the declared answer key are as under:
 - i) Questions where Two Answering Options are correct:-

- i) Nullified Questions:-

It may be noted here that the candidates having marked either of the options as Answering Option for the questions where two Answering Options are correct, will be awarded marks. However, no marks will be awarded to the candidates opting for both the options. Further, in case of question which is nullified the

candidates would be allocated marks for the questions which are nullified/deleted as per Rule XV (17) of J&K SSB conduct of Examination Rules, 2013.

The shortlisting of the candidates for the posts shall be done on the basis of the revised key and no further claims in this regard shall be entertained by the Board.

Further, the candidates in the ratio of 1:10 shall be shortlisted from the written test for driving test, (which is of qualifying nature) strictly as per notified criteria.
