Sub:- Selection of candidates for the post of "**Dental Assistant/Junior Dental Technician**" (Health and Medical Education Department) District Cadre Kulgam pursuant to Advertisement Notification No. 01 of 2016 under item No. 084.

Reference: Decision of **152<sup>ND</sup>** meeting of Board of JKSSB.

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Dental Assistant/Junior Dental Technician**" (Health and Medical Education Department) District Cadre Kulgam pursuant to Advertisement Notification No. 01 of 2016 under item No. 084 and recommended the same to the Health and Medical Education Department vide letter No.SSB/Secy/ Sel/2018/10186-92 dated 04.10.2018; and


2/ Whereas, the recommendation in respect of candidate namely **Seerat Rasool D/o Mr Gh Rasool Hajam** was kept withheld subject to clarification with regard to date of declaration/completion of diploma in Dental Assistant; and

3/ Whereas, the matter with regard to date of declaration of result was taken up with Controller of Examination J&K State Para Medical Council Srinagar vide this office letter No. SSB/Secy/Sel/77/2018/629 dated 22.01.2019 with the request to intimate the date of declaration/completion of diploma in Dental Assistant of one candidate namely **Seerat Rasool D/o Mr Gh Rasool Hajam**; and

4/ Whereas, President (Principal/Dean) J&K State Para Medical Council Srinagar in turn vide letter No. SPMC/GMC/Sgr/3416-3420 dated 26.02.2019 has intimated that the candidate namely **Seerat Rasool D/o Mr Gh Rasool Hajam** has qualified from the Government AMT School Anantnag during the session Feb-March, 2016 and the result of the said session was declared on **21.11.2016**, while as the cut-off date for the said advertisement notification/post was fixed on **25.06.2016**; and

4/ Whereas, the case was processed in the Board and it was decided that since the result of the candidate has been declared after the prescribed cut-off date, the candidate hence was not eligible and his candidature for the post warrants cancellation.

In the backdrop of the situation narrated herein above, the withheld selection of **Seerat Rasool D/o Mr Gh Rasool Hajam figuring at S.No.01 under OSC category** for the post of "**Dental Assistant/Junior Dental Technician**" (Health and Medical Education Department) District Cadre Kulgam pursuant to Advertisement Notification No. 01 of 2016 under item No. 084 is cancelled/withdrawn abinitio.
