## NOTICE

**Subject: - Selection of the candidates for the post of “Gram Sevika” (Department of Rural Development & Panchayati Raj), District Cadre Doda, Rajouri & Ramban under Item Nos. 485, 588 & 606 respectively advertised vide Advt. Notice. No. 06 of 2015, dated 01/09/2015.**

Whereas, Department of Rural Development & Panchayati Raj vide letter No. RD&PR/Estt/NG/145/205, dated 14.08.2015 among other posts referred, 05 posts of Gram Sevika (Doda = 01 post, Rajouri = 01 post and Ramban = 03 posts); and

Whereas, the said posts were advertised in terms of Advertisement Notification No. 06 of 2015, dated 01/09/2015 under item Nos. 485, 588 & 606 respectively; and

Whereas, the nomenclature of these posts was Gram Sevika, only female candidates were supposed to apply for these posts. However, while framing the final selection list for the posts it come to fore that some male candidates had also applied for the said posts and are finding place in the final selection list; and

Whereas, the matter with regard to the eligibility of the male candidates for the post of Gram Sevika was placed before the Board in its 151<sup>st</sup> Board Meeting held on 25<sup>th</sup> of March, 2019 for discussion and appropriate decision; and

Whereas, the issue was discussed threadbare by the Board, and it was decided that all male shortlisted candidates called for document verification and interview for the post of Gram Sevika, District Cadre Doda, Rajouri and Ramban shall be deemed/treated as in-eligible.

Now therefore, in light of the facts and circumstances so narrated herein above, the following male candidates are hereby declared not eligible for the posts of Gram Sevika (Department of Rural Development & Panchayati Raj), District Cadre Doda, Rajouri & Ramban under Item Nos. 485, 588 & 606 respectively advertised vide Advt. Notice. No. 06 of 2015, dated 01/09/2015:
