**Subject:-** Cancellation of candidature of candidates for the post of "Library Assistant" (School Education Department) District cadre Baramulla, item No.083 (02 of 2017).


**Reference:** Decision of 155th meeting of Board of JKSSB.

- 01) Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Library Assistant" (School Education Department) District Cadre Baramulla under item No.083 (02 of 2017). and forwarded the same to the School Education Department, vide letter No.SSB/Secy/Sel/2018/5764-71 dated 06-06-2018 for further course of action; and
- 02) Whereas, amongst others, the recommendation of a Candidate namely **Lubina Gazal D/O Sheikh Farooq Ahmed figuring at S.No.07/OM/RBA Category** had been kept withheld subject to production of valid category certificate; and
- 03) Whereas, the said candidate was required to furnish the deficient documents in respect of her candidature within 30 days and she furnished the said certificate in the Board for release of her withheld recommendation; and
- 04) Whereas, thereafter the matter with regard to authentication of the category certificate submitted by the candidate was taken up with Tehsildar Uri, vide letter No. SSB/Secy/Sel/149/2018/1038 dated 01/02/2019, the reply to which is still awaited; and
- 04) Whereas, meanwhile the candidate furnished an undertaking duly sworn before Judicial Magistrate first class stating therein that she was not willing to join the post under reference and has no objection if her candidature for the same is cancelled/withdrawn ab-initio; and

- 05) Whereas, it was presumed that she is not interested in getting appointed against the said post and hence her candidature needs to be cancelled, so that waiting list already forwarded to the department can be operated, if required; and
- 07) Whereas, the matter in its entirety was placed in the Board in its 155<sup>th</sup> meeting for discussion and appropriate decision thereof, wherein it was decided that since the candidate is not interested in getting appointed against the post under reference, her candidature needs to be cancelled so that the deserving candidate(s) in the waiting list get a chance of employment; and
- 08) Whereas, thereafter, the Board unanimously decided that selection in respect of the candidate for the post be cancelled so that the Department may operate the waiting list already forwarded to it.

Now, therefore, in view of the facts and circumstances so narrated herein above, the candidature of the candidate namely **Lubina Gazal D/O Sheikh Farooq Ahmed figuring at S.No.07/OM/RBA Category** for the post of "Library Assistant" (School Education Department) District Cadre Baramulla under Item No 083 (02 of 2017) is cancelled/withdrawn ab-initio and the Department is requested to operate the waiting list, under rules and norms, if required.
