Subject:- Cancellation of candidature of candidates for the post of "Patwari" (Revenue Department) District cadre Ramban, item No.604 (06 of 2015).

Reference: Decision of 155th meeting of Board of JKSSB.

- 01) Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Patwari" (Revenue Department) District Cadre Ramban under item No. 604 (06 of 2015) and forwarded the same to the Revenue Department, vide letter No.SSB/Secy/Sel/J/20/2019/573-79 dated 22-01-2019 for further course of action; and
- 02) Whereas, amongst others, the recommendation of a Candidate namely **Irshad Ahmed S/O Gh.Qadir figuring at S.No.03/OM/RBA Category** had been kept withheld for want of certain clarification/furnishing of documents; and
- 03) Whereas, the said candidate was required to furnish the deficient documents in respect of his candidature within 30 days and he choose not to furnish the same and accordingly a notice dated 15-03-2019 in this regard was issued giving him another 15 days time but the candidate again did not respond; and
- 04) Whereas, thereafter the said candidate was served a final notice vide this office No.SSB/Secy/Sel/20/19/J/2655-57 dated 24-04-2019 asking him to furnish the requisite document within 10 days failing which his selection against the said post shall be cancelled without further notices; and
- 05) Whereas, the said candidate has again failed to furnish the requisite documents for release of his withheld recommendation for the post under reference and it was presumed that he is not interested in getting appointed against the said post and hence his candidature needs to be cancelled, so that waiting lists already forwarded to the department can be operated, if required.

06) Wherea , the matter was considered by the Board in its 155th Board meeting wherein it was decided that selections in respect of the candidate be cancelled so that the deserving candidate in the waiting list get a chance of employment.

07 Now, therefore, in view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Irshad Ahmed S/O Gh.Qadir figuring at S.N J.03/OM/RBA Category** for the post of "Patwari" (Revenue Department) District Centre Ramban under item No. 604 (06 of 2013) is cancelled/withdrawn ab-initio and the recruiting department is requested to operate the waiting list, if required.
