1. J&K Services Selection Board, issued provisional shortlist of candidates for Document and Bio-metric Verification for the post of Telephone Supervisor, (Health and Medical Education Department (GMC Kathua)), Divisional Cadre Jammu Advt/Item No. 05/2019/038 among various categories of posts vide this office notice No SSB/Secy/Sel/2019/5160-66 dated 05-10-2019. The category wise breakup for the post of Telephone Supervisor, Advt/Item No 05/2019/038 was (OM=01, RBA=01 and SC=01). But due to typo graphic error, SC candidates have been shown shortlisted under RBA category and ST category candidates shown shortlisted under SC Category. Now the candidates who are shortlisted under RBA category may be treated as SC category and the ST candidates who are shortlisted under SC category may be treated as null and void.
2. The provisional shortlist of candidates for the post under reference of RBA category is required to be shortlisted.
3. Now, the Board has issued the provisional short list of the candidates for document and Bio-metric Verification for the post Telephone Supervisor, (Health and Medical Education Department (GMC Kathua)), Divisional Cadre Jammu Advt/Item No. 05/2019/038 (under RBA category) and the candidates are required to appear before document and Bio-metric Verification on 24<sup>th</sup> of October, 2019 onwards as per name/parentage shown in the Annexure "A" against each, Camp office, J&K Services Selection Board, Sehkar Bhawan, Panama Chowk, Jammu at 9.30 am Sharp.
4. The said candidates are required to appear before the Document Verification Committee with the following documents in original along with two photocopies sets of the same duly self-attested.
  1. Copy of Online Application form.
  2. D.O.B Certificate (10<sup>th</sup> Diploma /Marks card).
  3. Reservation category certificate, if applicable.
  4. Permanent Resident certificate.

5. Other documents as per the advertisement.
  6. Bonafide certificate on the format prescribed by the Board duly issued by the Controller /Registrar of the concerned University in respect of candidates, who have obtained degrees from the Institute/Universities/ Colleges outside the State of J&K, other than Central Universities.
5. Some candidates are figuring in reserve categories, based on the details they have incorporated in their data i.e. online application form. Their respective claims on this account are further subject to production of valid reserve category certificate substantiating their candidature under the respective categories during the process of counselling and document verification, in addition to the normal process of verification indicated at para 3.
6. The subsequent selection shall be subject to outcome of writ petition(s), if any, pending in the matter before any competent court of Law.
