Sub:- Cancellation of candidature of candidates for the post of "**Sub Inspector**" (Finance Department) Divisional Cadre Kashmir pursuant to Advertisement Notification No. **05 of 2015, item No. 214.**

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Sub Inspector**" (Finance Department) Divisional Cadre Kashmir pursuant to Advertisement Notification No. **05 of 2015, item No. 214** and recommended the same to the Finance Department vide letter No.SSB/ Secy/Sel/2019/148-54 dated 08.01.2019; and


2/ Whereas, the recommendation in respect of candidates namely **Saima Wali Pandith** D/o Wali Mohd Pandith and **Mudasir Yousuf Bhat** S/o Mohamad Yousuf Bhat figuring at S.No.10/OM and 03-Waiting/OM respectively were kept withheld for want of certain documents which were to be furnished within 30 days but they did not furnish the same; and

3/ Whereas, these candidates were served a notices vide this office No. SSB/ Secy/Secy/Sel/18/2019/5762-67 dated 21.11.2019 again asking them to furnish the requisite document within **21 days** from the date of issuance of the said notices failing which their selection/recommendation against the said post shall be cancelled without further notices, the candidates again did not respond; and

4/ Whereas, thereafter these candidates were served a final notice vide this office No. Secy/Secy/Sel/18/2019/6320-25 dated 26.12.2019 asking them to furnish the requisite documents within 10 days from the date of issuance of the said notice failing which their selection/recommendation against the said posts shall be cancelled without further notices. The candidate again did not furnish the same; and

5/ Whereas, the matter was placed before the Board wherein it was decided that the candidature/selection of the candidates namely **Saima Wali Pandith** D/o Wali Mohd Pandith and **Mudasir Yousuf Bhat** S/o Mohamad Yousuf Bhat figuring at S.No.10/OM and 03-Waiting/OM respectively be cancelled so that the deserving candidate against the post of "**Sub Inspector**" in the waiting list get a chance of employment.

7/ Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidates namely **Saima Wali Pandith** D/o Wali Mohd Pandith and **Mudasir Yousuf Bhat** S/o Mohamad Yousuf Bhat



figuring at S.No.10/OM and 03-Waiting/OM respectively for the post of "**Sub Inspector**" (Finance Department) Divisional Cadre Kashmir pursuant to Advertisement Notification No. **05 of 2015, item No. 214** is cancelled/ withdrawn ab-initio.
