1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of **"Cameraman"** (Information Department), District Cadre Shopian, item No. 443 (06 of 2015 dated 01.09.2015) and recommended the same to the Information Department vide letter No. SSB/Secy/Sel/2018/3116-22 dated 23.03.2018 for further course of action; and

2/ Whereas, the selection of one candidate namely **ZUBAIR AHMAD MIR S/O BASHIR AHMAD MIR** figuring at S.No.01 under OM category has been kept withheld and is subject to clarification from competent authority with regard to validity of experience and recognition of institute ; and

3/ Whereas, the matter with regard to validity of experience and recognition of institute was taken up with Information Department, Civil Secretariat, Jammu vide this office letter No. SSB/Sel/Secy/2018/4174 dated 12.04.2018 with the request to clarify whether **experience certificate of Mission Kashmir submitted by the above said candidate** can be considered for the post under reference for which prescribed qualification as per indent is **"Science Graduate with three (03) years experience in still photography from any recognized institute"** or otherwise ; and

4/ Whereas, in response, the Information Department, Civil Secretariat, Jammu vide letter No. ID/Estt/11/2014 dated 26.12.2019 intimated that the matter was taken up with the Technical Education Department has conveyed that Director Technical Education J&K vide his letter No. DTE/Trgs/401/Verif-54/1087-89 dated 17.10.2018 has clarified that M/S Mission Kashmir is not an institute registered with Technical Education Department and that the Technical Education Department affiliates private Polytechnics/ITI's which are offering courses for students and are capable of giving training as per recognized norms and rules.. The indenting department has accordingly requested that the post of Cameraman be filled up strictly as per the Recruitment Rules of the Department notified vide SRI No. 123 dated 13.04.2015 where under the method of recruitment and minimum qualification for the said post is **"Science Graduate with 03 years experience in still photography from any recognized institute"**.

01. Whereas, The J&K Services Selection Board has issued the selection list of the candidates for the post of **Forest Guard (Forest Department) District Cadre Kupwara** pursuant to advertisement notification **No. 04 of 2013, Item No. 383**. The said list has been forwarded to the Indenting Department vide Letter No. **SSB/Secy/Sel/2018/9829-36** dated **07-09-2018** for further course of action, wherein the recommendation of below mentioned candidate was kept withheld for want of requisite documents/clarification:

Whereas, despite a lapse of many months the candidate did not furnish the requisite documents, and was accordingly served correspondence & notice vide No. **SSB/Secy/Sel/FG/Kup/2018/7648** dated **29.06.2018** and **SSB/Secy/Sel/242/2018/4767-70** dated **12.09.2019** (copy of which addressed to the candidate, published in daily news paper Srinagar Times dated **13.09.2019** and also uploaded on the official website of the Board) for furnishing the requisite documents which evoked no response.


03. Whereas, the Board vide letter No. **SSB/Secy/Sel.242/2018/5158** dated **04.10.2019** addressed to sub Divisional Magistrate Karnah with the request to convey Mr. Fareed Ahmad to appear in person the Secretary alongwith disability certificate within fortnight for ascertaining the genuineness of the

said disability certificate for taking further course of action in the matter. In reply, Sub Divisional Magistrate, Karnah vide letter No. SDMK/N/1065 dated 23.10.2019 stated that his office has informed Shri Fareed Ahmad S/o. Qaisar Din R/o. Draggard, Tehsil Karnah through Naib Tehsildar Chamkore vide letter No. SDMK/N/1034 dated 15.10.2019 which also evoked no response and subsequently submitted an affidavit of non-joining duly sworn before a judicial magistrate.

04. Whereas, Hon'ble Court passed in SWP No. 1593/2018, IA No.01/2018 titled "Mohammad Iqbal Kar V/S State of Jammu and Kashmir and others, as the Hon'ble High Court vide its order dated 17.07.2018 directed that the selection qua the respondent No. 07 (Fareed Ahmad S/o Kaiser Din) against the post of Forest Guard, District Cadre Kupwara under ST Category shall not be given effect. Now that the order has been modified by the Hon'ble Court vide its order dated 10.04.2019, there is no legal hitch as regards the finalization of selection with regard to the post reserved at S.No. 07 under ST Category.

05. Whereas, the matter was considered by in the 159th Board meeting wherein it was decided that selection in respect of the candidate be cancelled.

06. Now, therefore, in view of the facts and circumstances narrated herein above, the candidature of the candidate namely "Fareed Ahmad" for the post of Forest Guard (Forest Department) District Cadre Kupwara pursuant to advertisement notification No. 04 of 2013, Item No. 383 is canceled/withdrawn ab-inito.

Sub:- Cancellation of candidature of candidates for the post of "General Teacher" (School Education Department) item No. 005 (06 of 2017) District Cadre Ganderbal.

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "General Teacher" (School Education Department), item No. 005 (06 of 2017) District Cadre Ganderbal and recommended the same to the School Education Department vide letter No. SSB/Secy/Sel/36/2019/1551-57 dated 07.03.2019 for further course of action; and

2/ Whereas, among others, the recommendation in respect of one candidate namely **Mohd Imran Kalgan S/o Mohd Sidiq Kalgan** figuring at S.No.01 under ST category has been kept withheld and is subject to clarification regarding 15 years stay in district Ganderbal but he did not furnish the same; and


3/ Whereas, the said candidate was served a notice vide this office No. SSB/Secy/Sel/GLT/GBL/2018/4044-47 dated 11.07.2019 again asking him to furnish the requisite document within 21 days from the date of issuance of the said notice failing which the selection/recommendation against the said candidate shall be cancelled without further notices. The candidate again did not furnish the same; and

4/ Whereas, thereafter the said candidate was served a final notice vide this office No. No. SSB/Secy/Sel/GLT/GBL/2018/5037-40 dated 30.09.2018 asking him to furnish the requisite documents within 10 days from the date of issuance of the said notice failing which his selection/recommendation against the said posts shall be cancelled without further notices; and

5/ Whereas, in response, the candidate has submitted an undertakings in the shape of affidavit duly attested by Judicial Magistrate 1st Class Ganderbal, stating therein that he is not interested in joining against the said post; and

6/ Whereas, the matter was considered by the Board in its 159th meeting wherein it was decided that the candidature/selection of the above said candidate be cancelled.

Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Mohd Imran Kalgan S/o Mohd Sidiq Kalgan** figuring at S.No.01 under ST category for the post of "General Teacher" (School Education Department), item No. 005 (06 of 2017) District Cadre Ganderbal is cancelled/withdrawn ab-initio.
