Whereas, the Services Selection Board forwarded select list of candidates for the post of Teacher (Education Department) in pursuance to Advertisement Notification No. 07 of 2010, under Item No. 697, (District Cadre Kathua) to Education Department vide No.SSB/Sel/Secy/013/294-96 Dated:-11-01-2013.

Whereas, the recommendation of Jyoti Prashad S/O Des Raj figuring at S.No.04/ST/Wait had been kept withheld till production of bonafide certificate of Graduation.

Whereas, the Service Selection Board has issued a general notice to all the candidates vide No. SSB/Secy/Sel/013/4535-41 Dated:-07-12-2013 to furnish the requisite documents but the candidate namely Jyoti Prashad S/O Des Raj figuring at S.No.04/ST/Wait has not submitted the requisite documents and ;

Whereas, the candidate namely Jyoti Prashad S/O Des Raj figuring at S.No.04/ST/Wait has furnished affidavit bearing date 29-10-2013 duly attested by the Judicial Magistrate 1st Class, pledging therein that he is not willing to join as he is already working in PWD Department and;


Whereas, having no action taken by the Department, the petitioner Raj Kumar S/O Prem Chand figuring at S.No.05/ST/Wait approached the Hon'ble High Court through the medium of SWP No. 1694 in which the Hon'ble High Court directed as under on 28-10-2016 and;

"The petition is accordingly disposed of with a direction to the Services Selection Board to consider the claim of the petitioner and pass appropriate orders within three weeks from today. Based upon the recommendation of the Services Selection Board, respondent No.1 shall pass appropriate orders within three weeks thereafter".

Whereas, in pursuance to court order dated 28-10-2016 read with the above stated facts, the claim of the petitioner for the cancellation of the selection of the candidate namely Jyoti Prashad S/O Des Raj figuring at S.No.04/ST was examined and considered ; and

Whereas, the instant case was placed before the 154th Board meeting, wherein , it was decided that the final notice be given to the candidate and accordingly, final notice dated 28-11-2019 has been issued giving 07 days time to submit the requisite documents but the candidate namely Jyoti Prasad has not approached the Board; and

In compliance to the judgment of Hon,ble High Court dated. 28-10-2016 passed in SWP No. 1694/15 and MP NO. 2/2015, 1/2010 and 1/2016 dated.28-10-2016 coupled with aforesaid facts the selection of the candidate namely Jyoti Prashad S/O Des Raj figuring at S.No.04/ST/wait, is hereby cancelled.

Subject:- Cancellation of selection of the candidate for the post of "Driver" (Agriculture Department), District Cadre Ramban vide item No.892(01 of 2011), dated 31-01-2011.

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Driver" (Agriculture Department), District Cadre Ramban vide item No.892(01 of 2011), dated 31-01-2011 and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/2017/8845-51 dated 11-09-2017 for further course of action; and

2) Whereas, the selection of the candidate namely Abbas Ali S/O Aliyas Ali R/o Chander Kote, Kunfer Ramban, figuring at S.No. 01/OM was kept withheld and subject to clarificate with regard to date of endorsement for driving heavy vehicle and clarification of Date of Birth in Driving Licence and Middle pass certificate; and

3) Whereas, the Board took up the matter with the Assistant Regional Transport Officer, Ramban vide letter No.SSB/Secy/Sel/2017/2259 dated 28-02-2018 followed by No. SSB/Sel/Secy/2018/3813 dated 06-04-2018 regarding verification of Driving licence and date of endorsement of Driving licence to Heavy Goods Vehicle. In response of this office letter a refrence was received from the Assistant Regional Transport Officer, Ramban, vide letter No.ARTO/Rbn/2018/153/ dated 28-07-2018, which reveals that the driving licence of the above said candidate was endorsed for HGV(Trans) vide endorsement No.JK19/DLE/0000096/2017 dated 22-04-2013; and


4) Whereas, the endorsement for HGV(Trans) vide endorsement No.JK19/DLE/0000096/2017 has been issued after cut off date; and

5) Whereas, the last date of submission application form was 15-03-2011; and

6) Whereas, the case of the candidate was placed in the 159th Board meeting and Board has Ld. decided to cancel the selection of the candidate, as the Driving licence has been issued/endorsed for HGV(Trans) after cut off date as per verification received from Assistant Regional Transport Officer, Ramban.

Now, therefore, in view of the above position, the withheld selection of Abbas Ali S/O Aliyas Ali R/o Chander Kote, Kunfer Ramban, figuring at S.No. 01/OM for the post of "Driver" (Agriculture Department), District Cadre Ramban vide item No.892(01 of 2011), dated 31-01-2011 is hereby cancelled abinitio.
