

- 1) Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of "Jr.Assistant" (School Education Department), District Cadre Kathua vide item No.078 (01 of 2016 dated 01-06-2016) and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/2018/8187-93 dated 11-07-2018 for further course of action; and
- 2) Whereas, the selection of the candidate namely Himat Singh S/O Hari Singh R/o Vill. Tridwan P.O. Hatli Kathua, figuring at S.No. 03/RBA was kept withheld and subject to production of bonafide certificate of Graduation; and
- 3) Whereas, the candidate has submit the Bonafide certificate issued by the Dy.registrar(DE), Guru Jambheshwar Univeristy of Science and Technology, Hisar vide No.DE-4/18/11 Dated 16-01-2018; and
- 4) Whereas, the Board took up the matter with the Deputy Registrar, Guru Jambheshwar Univeristy of Science and Technology, Hisar (Haryana) vide letter No.SSB/Sel/Verif/193/J/2018/3026 daled 11-05-2019 regarding verification of Bonafide certificate. In response of this office letter a refrence was received from the Deputy Director(DE), Guru Jambheshwar Univeristy of Science and Technology, Hisar (Haryana) vide No.DE-4/19/618 dated 14-06-2019, which reveals that the said bonafide certificate was issued by his office under enrollment No.07031901108 vide letter No.DE-4/18/11 dated 16-01-2018 and the student has completed his course through Kawa Institute of Management & Technology, N.H.Bye Pass Road, Narwal, Jammu. Further, the Board also took up the matter with the Registrar, University Grants Commission, Bhadurshah Zafar Marg, New Delhi-110002 dated 11-05-2019 regarding status of the university. In response of this office letter a refrence was received from the Under Secretary, University Grants Commission vide No.F.5-3/2019(CPP-1/PU) dated 17-07-2019, which reveals that the Guru Jambheshwar Univeristy of Science and Technology is not authorized to open study centre/off campus centre beyond the territorial jurisdiction of the State as per the judgment of Hon'ble Supreme Court of India In the case of Prof.Yash Pal Vs State of Chhattisgarh; and
- 5) Whereas, the case of the candidate was placed in the 159th Board meeting and Board decided to cancel the selection of the candidate as per the ambit of Govt. order No.252-HE of 2012 Dated 30-05-2012 and in view of communication from the University Grants Commission.

Now, therefore, in view of the above position, the withheld selection of **Himat Singh S/O Hari Singh R/o Vill. Tridwan P.O. Hatli Kathua, figuring at S.No. 03/RBA "Jr.Assistant" (School Education Department), District Cadre Kathua vide item No.078 (01 of 2016 dated 01-06-2016)** is hereby cancelled abinitio.
