Whereas, the Home Department vide letter No. Home/FSL/17/2019 dated.24.10.2019 has communicated that:

i. The department is in the process of re-organizing the FSL with creation of additional posts, abolition and re-designation of posts, as such the posts have to be referred afresh for recruitment after revising the J&K, FSL Recruitment Rules.

ii. The above **21 detailed posts shall be deemed to have been withdrawn** and no further selection process be carried out against these posts.

- iii. Upon reference of posts of J&K Forensic Science Laboratory (FSL) afresh, a provision be included in the advertisement notification to be issued, stating therein, that the candidates who have earlier applied for appointment of the posts need not apply again provided they are eligible for the posts in terms of qualification prescribed in Recruitment rules, so as to protect the upper age limit of these candidates; and,

Whereas, the matter was placed before the Board in its 159th meeting on 14-12-2019 and it was decided that Board may issue a notice for the general information of the candidates.

Now, therefore, in view of the aforementioned facts, the 21 posts of Home Department advertised vide Advertisement Notification Nos. 06/2019/001 to 06/2019/007 Dated: 01-02-2019 and 01 of 2013 dated: 16-02-2013, are hereby withdrawn, and that the candidates who have earlier applied for appointment of the posts, need not apply again provided they are eligible for the posts in terms of qualification prescribed in Recruitment rules, so as to protect the upper age limit of these candidates provided if these posts are referred afresh.
