- 2) Whereas, the Board conducted a Common written test for the above said posts/Notification on 12th of October 2019; and
- 3) Whereas, the result of written exam was declared on 03.12.2019 and the shortlisted candidates were called for Document Verification w.e.f 12th of December 2019 onwards; and
- 4) Whereas, in order to avoid repetition of candidates in the selection lists for the above said posts, it is imperative to seek preferences /choices from the candidates who have been shortlisted for Document Verification for more than one items.
- 5) Now therefore in view of the above and after taking all the relevant factors into consideration, it is notified that the candidates who have been shortlisted and appeared for Document Verification for more than one item are required to submit their preference(s) for different items/notifications as per format given below in the Divisional Office, J&K Services Selection Board, Divisional Office, Paloura, Jammu OR Divisional Office, J&K Services Selection Board, Parray Pora Srinagar (as the case may be) by or before 12th of March, 2020. However, while exercising the preference, the following points shall be borne in mind: -
- That the Board will consider the Preferences only if the candidate finds place within the selection zone in more than one item.
 - That the Preferences shall be operated strictly in order of the merit & there shall be no compromise in the merit under any condition.
 - That those who fail to submit the preferences as per prescribed format and within the notified cut-off date will not get another opportunity for submission at a later stage. In such a case, the candidate shall be considered for one item in the selection list as per Board choice and no claim in this regard shall be entertained at any later stage by the candidate.
