
Kindly refer to this office letter No. SSB/Secy/Sel/06/K/2020/449-55 dated



3/ Whereas, the candidate has furnished marriage certificate issued by Tehsildar Sopore mentioning therein that Miss Batuol D/o Mushtaq Ahmad Kirmani R/o P.C.Depot Qamarwari, Srinagar Tehsil Srinagar District Srinagar Kashmir is really and legally wedded with Mr. Gulam Rasool Dar S/o Abdul Salam Dar R/o Khushall Colony Sopore on 25th March, 2018. The candidate has also furnished B.Ed Degree issued by Vice Chancellor University of Kashmir; and

4/ Whereas, from perusal of the application form submitted by the candidate for the above said post, it has been found that the candidate has shown herself as married at the time of filing of online application form; and

4/ Whereas, the case was processed in 163rd Board meeting wherein it was decided that the marriage of the candidate under reference has been made outside district, therefore is not eligible for applying any post in District Srinagar.
