Sub: Cancellation of selection of the candidate for the post of "Patwari"
(Department of Disaster Management Relief, Rehabilitation and
Reconstruction) Under Prime Minister's Special Package) District
Cadre Bandipora vide Item No. 142 (4 of 2017).

Whereas, the J&K Services Selection Board has issued the
selection list of the candidates for the post of "Patwari" (Department of
Disaster Management Relief, Rehabilitation and Reconstruction) under
Hon'ble Prime Minister's Special Package), Item No.142 (04 of 2017)
District Cadre Bandipora. The said list has been forwarded to the
Indenting Department vide Letter No. SSB/Secy./Sel/83/2019/3509-15
dated 18-06-2019 for further course of action; and

Whereas, the recommendation of the candidate namely Raj
Kumar Bhat S/o Hari Krishan Bhat R/o Nagrota, Jammu have been kept
withheld for want of requisite documents/clarification; and

Whereas, despite a lapse of many months the candidate did not
furnish the requisite documents, and subsequently submitted an
undertaking of non-joining duly sworn before a judicial Magistrate.
Notwithstanding the furnishing of said affidavit the said candidate were
accordingly served notice vide this Office No. SSB/Secy/Sel/2019/5809-
13 dated 28-11-2019 for furnishing the requisite documents which
evoked no response; and.

Whereas, thereafter, a final notice was served to the candidate
vide this Office No. SSB/ Sel/Secy/2019/6356-59 dated 30-1-2019 for
furnishing the requisite documents which also evoked no response ;
and

Whereas, the mater was placed before the Board in its 164th
Board Meeting wherein it was decided that the candidature/selection of

the candidate be cancelled so that the deserving candidate in the waiting list get a chance of employment.

In view of the afore stated background, the candidature of the candidate for the post of "Patwari" (Department of Disaster Management Relief, Rehabilitation and Reconstruction) under Hon'ble Prime Minister's Special Package, Item No.142 (04 of 2017) District Cadre Bandipora is cancelled/withdrawn ab-initio and the intending department is requested to operate the waiting list, if required.
