Subject:- Cancellation of candidature of candidate for the "IEC Worker" under Hon'ble Prime Minister Special Package ( For Kashmiri Migrants) Divisional Cadre Kashmir (Rural and Panchayati Raj Department), 04 of 2017 dated 28-11-2017 under item No.013.


Reference: Decision of 169<sup>th</sup> meeting of Board of JKSSB.

Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "IEC Worker" under Hon'ble Prime Minister Special Package ( For Kashmiri Migrants) Divisional Cadre Kashmir (Rural and Panchayati Raj Department), 04 of 2017 under item No.013 and recommended the same to the Forest Department vide letter No. SSB/Secy/Sel/91/2019/3034-40 dated 11-05-2019 for further course of action; and

Whereas, amongst others, the recommendation of one candidate namely **Naseem Kousar D/O Akhtar Hussain R/O Village Tragan Zamalgam, Tehsil Doru District Anantnag A/P Satha, Tehsil and District Samba figuring at S.No. 02 under ST Category** for the post of "IEC Worker" under Hon'ble Prime Minister Special Package ( For Kashmiri Migrants) Divisional Cadre Kashmir (Rural and Panchayati Raj Department), 04 of 2017 under item No.013 had been kept withheld for want of certain clarification/furnishing of documents; and

Whereas, the said candidate was required to furnish the deficient documents in respect of her candidature within 30 days and She choose not to furnish the same; and


Whereas, the two notices vide this office No. SSB/Secy/Sel/91/2019/1447-51 dated 24-02-2020 and



SSB/Secy/Sel/91/2019/2331-34 dated 13-03-2020 were served to them, asking them to furnish the requisite documents within 10 and 07 days, failing which her selection against in the said post shall be cancelled without further notices; and

Whereas, the said candidate has again failed to furnish the requisite documents for release of his withheld recommendation for the post under reference and it was presumed that they were not interested in getting appointed against the said post and hence his candidature needs to be cancelled, so that waiting list already forwarded to the indenting department.

Now, therefore, in view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Naseem Kousar D/O Akhtar Hussain R/O Village Tragan Zamalgam, Tehsil Doru District Anantnag A/P Satha, Tehsil and District Samba figuring at S.No. 02 under ST Category** for the post of "IEC Worker" under Hon'ble Prime Minister Special Package ( For Kashmiri Migrants) Divisional Cadre Kashmir (Rural and Panchayati Raj Department), 04 of 2017 under item No.013 is cancelled/withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required.
