**Subject: WP(C) No. 1922/2019, titled Shruti Saliada Vs State & Ors., CCP (S) No.449/2019 titled Shruti Saliada Vs Ranjeet Singh (Selection List of candidates for the post of Jr. Assistant (School Education Department) District Cadre Kathua, pursuant to Advertisement Notice No. 01 of 2016 dated 01.06.2016, Item No.78).**

Whereas, the Jammu & Kashmir Services Selection Board issued the Selection List of Candidates for the post of Junior Assistant, (School Education Department) District Cadre, Kathua under Item No 78 pursuant to Advertisement Notice No. 01 of 2016 dated 01.06.2016 and the same was forwarded to the Indenting Department vide communication no. SSB/Secy/Sel/2018/8187-93 dated 11.07.2018.

Whereas, the recommendation of candidate namely Deepak Jyoti D/o Amar Nath figuring at Serial No. 01 under OSC Category was Kept Withheld subject to production of within date valid OSC Category Certificate.

Whereas, two notices for getting withheld recommendation released was served upon the candidate namely Deepak Jyoti to submit requisite document vide Notice No. SSB/Secy/Sel/193/18/J/1280-83 dated 26.02.2019 and SSB/Secy/Sel/2018/5300-03 dated 15.10.2019 respectively but she failed to submit the same.

Whereas, feeling aggrieved the candidate namely Shruti Saliada, approached the Hon'ble High Court by way of SWP No. 1922/2019 titled 'Shruti Saliada V/S State and others, and the Hon'ble High Court vide judgment dated 25.02.2019 has disposed of the matter and the operative part of the judgment is reproduced as:


*"Let a decision in this regard be taken by the respondent No. 1 within a period of four weeks from the date, a copy of this order is received by him. It would be in the fitness of things to grant one last opportunity to the respondent No. 2 to fulfil the deficiency. Further course of action depends upon the decision as shall be taken by the respondent No. 1".*

Whereas, the petitioner again approached the Hon'ble High Court by way of Contempt Petition bearing No CCP(S) No.449/2019 in WP(c) 1922/2019 titled Shruti Saliada V/s Ranjeet Singh seeking contempt proceedings against the respondent for his wilful defiance of order dated 22.05.2019 passed by the Hon'ble High Court in WP(c) 1922/2019 titled Shruti Saliada V/s State and Others

Whereas, in compliance with the Hon'ble High Court Order dated 22.05.2019 passed in the afore titled writ petition, the J&K Services Selection Board has served a final notice vide Endorsement No.SSB/Secy/Sel/2018/5300-03 dated 15.10.2019 to the candidate namely Deepak Jyoti to submit within date valid OSC Category certificate within period of seven days in the J&K Services Selection Board, but she failed to submit the same till date.

Whereas, it is pertinent to add that the notices referred to above being sent on the mailing address of the candidate, have also been published in leading dailies of the Union territory through the information Department.

In the backdrop of the situation narrated herein above, the withheld selection of **Deepak Jyoti D/o Amar Nath R/o Mehtapur, District Kathua, J&K** figuring at Serial No 01 under OSC Category for the post of Jr. Assistant (School Education Department) District Cadre Kathua Under Item No.78 pursuant to notification No 01/2016 dated 01.06.2016 is cancelled/withdrawn ab initio.
