Subject:- **Cancellation of selection of the candidate for the post of "Work Supervisor" (Public Works Department), Divisional Cadre Jammu vide item No.194 (03 of 2012 dated 28-12-2012).**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of **"Work Supervisor" (Public Works Department), Divisional Cadre Jammu vide item No.194 (03 of 2012 dated 28-12-2012)** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/2016/21161-68 dated 19-12-2016 for further course of action; and


2) Whereas, the selection of the candidate namely **Maqsood Ahmed S/O Mohd Hafiz R/o Majhoor, Rajdhani, Thannamandi, District Rajouri, figuring at S.No. 12/OM/RBA** was kept withheld and subject to production of diploma Marks card and recognition of institute issuing diploma; and

3) Whereas, the candidate has submit the requisite certificate issued by the Secretary, Industrial Training Institute, (A unit of National Foundation) Jammu J&K State vide No.ITI/NF/CJ/D/M/B.C/0001 dated 15-04-2010 and ;

4) Whereas, the Board took up the matter with the Director, Technical Education Department, Jammu vide No.SSB/Sel/Verif/2018/620 Dated 16-01-2020 regarding verification/clarification of particulars of ITI Certificate /Diploma. In response of this office letter a refrence was received from the Indenting Department vide No.DTE/TRG/401/1938 Dated 30-01-2020, which reveals that the Industrial Training Institute (A unit of National Foundation Jammu) from which the candidate has done diploma in the trade of Masson (Building Construction) is not affiliated/registered with the Department of Technical Education J&K; and

5) Whereas, the case of the candidate was placed in the 169th Board meeting and Board decided to cancel the selection of the candidate as per the clarification received from the Director, Technical Education, Department, Jammu.

Now, therefore, in view of the above position, the withheld selection of **Maqsood Ahmed S/O Mohd Hafiz R/o Majhoor, Rajdhani, Thannamandi, District Rajouri, figuring at S.No. 12/OM/RBA for the post of "Work Supervisor" (Public Works Department), Divisional Cadre Jammu vide item No.194 (03 of 2012 dated 28-12-2012)** is hereby cancelled abinitio.



4) Whereas, the case of the candidate was placed in the 169th Board meeting and Board has been decided to cancel the selection of the candidate, in view of Ex-Serviceman recruitment rule.
