Subject:- Cancellation of candidature of candidate for the post of "Assistant Motor Vehicle Inspector," Transport Department under Hon'ble Prime Minister's Special Package for Kashmiri Migrants Divisional Cadre Kashmir under item No.021 vide Advertisement notice No. 04 of 2017 dated 28-11-2017.


Reference:- Decision 170<sup>th</sup> meeting of Board of JKSSB.

Whereas, the J&K Services Selection Board issued final Select List of the candidates for the post of Assistant Motor Vehicle Inspector," Transport Department under Hon'ble Prime Minister's Special Package for Kashmiri Migrants Divisional Cadre Kashmir under item No.021 vide Advertisement notice No. 04 of 2017 dated 28-11-2017 and recommended the same to the Secretary to the Government, Department of Disaster Management, Relief, Rehabilitation and Reconstruction, Civil Secretariat, Jammu vide letter No. . SSB/Secy/Sel/01(M)/2020/1006-12 dated 27-01-2020 for further course of action; and

Whereas, amongst others, the recommendation of one candidate namely **Rakesh Bhat S/O Avtar Krishan Bhat R/o Flat No.18, Lane No. 08, Block No.39, Jagti Township Government Middle School Jagti -181221, Jammu figuring at S.No. 06 under OM Category** for the above said post had been kept withheld for want of certain clarification/furnishing of documents; and


Whereas, the said candidate was required to furnish the deficient documents in respect of his candidature within 30 days and he choose not to furnish the same and instead submitted an affidavit duly sworn before Registrar, Judicial 1st Class, Jammu on 25 Feb 2020 that he was not interested in joining against the said post; and

Whereas, despite the furnishing of the affidavit it was deemed expedient to give notice to the candidate through print media and by post. Accordingly, two notices vide this office No. SSB/Secy/Sel/01/2020/1793-96 Dated:-06-03-2020 and SSB/Secy/Sel/01/2020/3064-67 Dated:-08-05-2020 were served to him, asking therein to furnish the requisite documents within 15 and 07 days respectively, failing which his selection against the said post shall be cancelled without further notices; and



Whereas, the said candidate has again failed to furnish the requisite documents for release of his withheld recommendation for the post under reference and it was presumed that he was not interested in getting appointed against the said post and hence his candidature needs to be cancelled, so that waiting list already forwarded to the indenting department, could be operated.

Now, therefore, in view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Rakesh Bhat S/O Avtar Krishan Bhat R/o Flat No.18, Lane No. 08, Block No.39, Jagti Township Government Middle School Jagti -181221, Jammu figuring at S.No. 06 under OM Category** for the post of Assistant Motor Vehicle Inspector," Transport Department under Hon'ble Prime Minister's Special Package for Kashmiri Migrants Divisional Cadre Kashmir under item No.021 vide Advertisement notice No. 04 of 2017 dated 28-11-2017 is cancelled/withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required.
