



Subject:- Cancellation of selection of the candidate for the post of "Jr.Asstt." (PHE/I&FC Department), Divisional Cadre Kashmir vide item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants.

- 1) Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of **"Jr.Asstt." (PHE/I&FC Department), Divisional Cadre Kashmir vide item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/M/43/2020/2784-90 dated 28-04-2020 for further course of action; and
- 2) Whereas, the selection of the candidate namely Neha Pandita D/O Chand Ji Pandita R/O H.No. 04 Lane No. 75 Saraswati Vihar Anand Nagar, Bohri, Om Shiv Saraf Palace, 180002, Jammu, figuring at S.No. 01/OM was kept withheld and subject to verification and recognition status of Institute issuing computer certificate and production of duration of computer course; and
- 3) Whereas, the candidate has submit the computer certificate issued by the Principal, G. S .Accounts, Lower Moti Bazar, Parade, Jammu vide No.GICS/GS-1112779 Dated 16-03-2016. As per her computer certificate she has successfully completed the prescribed course from 11-09-2015 to 10-02-2016(05 Months) and ;
- 4) Whereas, the case of the candidate was placed in the 170th Board meeting and Board decided to reject/cancel the selection of the candidate in view of the fact that she has produced five (05) months computer certificate which is at variance with the qualification prescribed by the Indenting Department, as per the Indent. (The Prescribed qualification for said post is Graduation with six months certificate course in computer).








Now, therefore, in view of the above position, the withheld selection of **Neha Pandita D/O Chand Ji Pandita R/O H.No. 04 Lane No. 75 Saraswati Vihar Anand Nagar, Bohri, Om Shiv Saraf Palace, 180002, Jammu, figuring at S.No. 01/OM for the post of "Jr.Asstt." (PHE/I&FC Department), Divisional Cadre Kashmir vide item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants** is hereby cancelled abinitio, for being ineligible to hold the aforesaid post, as per the relevant recruitment rules.
