
Subject:- **Cancellation of selection of the candidate for the post of "Jr.Asstt." (Power Development Department), Divisional Cadre Kashmir vide item No.010 ( 04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants.**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of **"Jr.Asstt." (Power Development Department), Divisional Cadre Kashmir vide item No.010 ( 04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/M/40/2020/2782-34 dated 28-04-2020 for further course of action; and


2) Whereas, the selection of the candidate namely **Amit Koul S/O Jawahir Lal Koul R/O H.No. H.No.-53, Hardutoru Bhatt, Mohalla, Hardutoru 192101, Anantnag, figuring at S.No. 01/OM** was kept withheld and subject to Production of clarification regarding date of declaration of result of 5<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> semester, production of bonafide as per format duly countersigned by competent authority(DE); and

3) Whereas, the candidate has submitted the Transcript of Bachelor of Technology and marks certificates of 5<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> semester issued by the Dy. Registrar, Rohtak University vide 5388 Dated 24-01-2019, which reveals that the date of completion of 5<sup>th</sup> and 6<sup>th</sup> semester are July 2018 and ;

4) Whereas, the case of the candidate was placed in the 170<sup>th</sup> Board meeting and it was decided to reject/cancel the selection of the candidate in view of the facts that the result of Bachelor of Technology 5<sup>th</sup>, 6<sup>th</sup> semester was declared after cut off date. The last date of receipt of application forms was **22-12-2017**.



Now, therefore, in view of the above position, the withheld selection of **Amit Koul S/O Jawahir Lal Koul R/O H.No. H.No.-53, Hardutoru Bhatt, Mohalla, Hardutoru 192101, Anantnag, figuring at S.No. 01/OM for the post of "Jr.Asstt." (Power Development Department), Divisional Cadre Kashmir vide item No.010 ( 04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants** is hereby cancelled abinitio.
