

- 1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Nursing and Para Medical Staff/Technical Assistant/Technician" (Health & Medical Education Department (GMC Baramulla), Divisional Cadre Kashmir advertisement/item No. 02/2019/029 and recommended the same to the Health and Medical Education Department vide letter No. SSB/Secy/Sel/126/K/2019/6193-99 dated 18.12.2019 for further course of action; and
- 2/ Whereas, among others, the recommendation of one candidate namely **Owais Kamran Nazki S/o Abdul Qader Nazki** figuring at **S.No.05/0M** has been kept with held subject to clarification with regard to equivalence/ relevance of course; and
- 3/ Whereas, the candidate has furnished certificate of Proficiency in Medical Assistant 2<sup>nd</sup> Class issued by **INSTITUTE OF NAVAL MEDICINE** mentioning therein that the candidate has undergone prescribed course of studies and practical training for a period of **31 weeks** and passed the qualifying examination of "Medical Assistant 2nd Class on **01.05.2004**
- 4/ Whereas, the qualification prescribed for the post in question as per indent/ advertisement is "10+2 with Science or above qualification with diploma in Medical Assistant Course from any recognized Institute; and
- 4/ Whereas, the case was placed in **163<sup>rd</sup> Board meeting** wherein it was decided that the candidate is not eligible as per qualification acquired by the candidate with respect to qualification prescribe for the post.
