ORDER No. 299 SSB of 2020

Dated 11 - 09 - 2020

Subject:- Cancellation of selection of the candidate for the post of "Jr. Staff Nurse" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Kathua) vide item No.005 (08 of 2019).

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of **"Jr. Staff Nurse" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Kathua) vide item No.005 (08 of 2019)** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/J/77/2020/2559-65 dated 02-04-2020 for further course of action; and

2) Whereas, the selection of the candidate namely **Bhavana Dogra D/O Baldev Raj R/o VPO Garhi Tehsil and District Udhampur, figuring at S.No. 01/OSC** was kept withheld subject to production of valid category certificate, unmarried certificate as on cut off date and degree; and


3) Whereas, the candidate has submitted the OSC category certificate issued by the Tehsildar Udhampur vide No.456-58/BCG dated 19-08-2013 valid for five years (Last date for receipt of application form was **28-03-2019**) and ;

4) Whereas, the case of the candidate was placed before the Board in its 172th Board Meeting and Board decided to seek clarification/validity of OSC certificate furnished by the candidate from Deputy Commissioner Udhampur, in light of the norms governing the field. In this context, the Board wrote a letter to the concerned vide No.SSB/Sel/Verif/77/20/2779 Dated 14-07-2020 for seeking clarification regarding the aforesaid OSC category certificate. In response of this office letter, the Deputy Commissioner Udhampur vide communication No.DC/Adm/OSC/Ver/322 Dated 31-07-2020 informed that the OSC category certificate of the said candidate was valid for five years(i.e 18-08-2018) and has not been renewed till date as per office record of Tehsildar Udhampur ; and

5) Whereas, the case of the above said candidate was again placed before the Board in its 173rd Board meeting and Board after examining the case, decided to cancel the selection candidature of the candidate on the basis of clarification received from the, Deputy Commissioner Udhampur.

Now, therefore, in view of the above position, the withheld selection of **Bhavana Dogra D/O Baldev Raj R/o VPO Garhi Tehsil and District Udhampur, figuring at S.No. 01/OSC for the post of "Jr. Staff Nurse" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Kathua) vide item No.005 (08 of 2019)** is hereby cancelled abinitio and indenting Department is requested to operate the waiting list under OSC Category, if required.
