**Subject:** Selection list of candidates for the post of “Store Keeper- cum- Clerk cum Computer Operator, Health and Medical Education Department” (Government Medical College Baramulla) Divisional Cadre, Kashmir (**Disposal of representation of Mr. Owais Kamran Nazki thereof**).

Whereas, an Indent/requisition was received by the Services Selection Board vide Communication No. ME/NG/53/2018-PF dated 11.01.2019, from Health and Medical Education Department for filling up of Non-Gazetted posts of five new Medical Colleges including the Post of Store Keeper- cum- Clerk cum Computer Operator, Health and Medical Education Department” for (Government Medical College Baramulla) Divisional Cadre, Kashmir;

Whereas, Jammu and Kashmir Services Selection Board vide Advertisement Notification No. 02 of 2019 dated 01.02.2019 advertised various posts including the post of “Store Keeper- cum- Clerk cum Computer Operator, Department of Health and Medical Education, (Government Medical College Baramulla), Division Cadre Kashmir under Item No 033 with the following breakup of Posts:-

**OM=29, RBA=11, SC=05, ST=05, OSC=01, ALC=02, Total=53;**

Whereas, the prescribed qualification for the aforesaid post as per the Indent received from the Indenting Department is as under:-

**“Graduation with certificate course in Computer application from any recognized University/Institute.”**

Whereas, the Jammu and Kashmir Services Selection Board approved the Selection List for the aforesaid post (GMC Baramulla) and the same was forwarded to the Indenting Department vide Communication No SSB/Secy/Sel/120/K/2019/5443-49 dated 18.10.2019

Whereas, the Health and Medical Education Department vide Communication No ME/NG/New/GMC/02/2019 dated 23.12.2019 has forwarded a copy of Communication No GMC/C/Bla/Adm/2019/2040-2041 dated 12.12.2019 of Government Medical College, Baramulla wherein it was stated that one Mr. Owais Kamran Nazki has submitted an application dated 10.12.2019 stating therein that:-

- i. The applicant was shortlisted for GMC Baramulla vide Notice No. SSB/Secy/Sel/2019/3997-4001 dated 10.07.2019 and figured at Serial No 4
- ii. The Ex-Serviceman Category candidate (Ajaz Ahmad Dar) with Sl. No. 2 was selected for the same post at both District Baramulla as well as District Anantnag vide Final Selection List of Advertisement Notice No. 02 of 2019 dated 01.02.2019 and vide Final Selection List of Advertisement Notice No. 01 of 2019 dated 01.02.2019


- iii. the above said Ex-Serviceman Category candidate had already joined GMC Anantnag vide Final Selection List of Advertisement Notice No. 01/2019/33 and he had submitted an affidavit for not joining in respect of GMC Baramulla.
- iv. The applicant requested that he being Shortlisted on Serial No. 4 in GMC Baramulla may be considered under Ex-Serviceman Category which falls vacant due to non-joining of Mr. Ajaz Ahmed Dar who figures at Serial No. 02 vide Final Selection List of Advertisement Notice No. 02 of 2019 dated 01.02.2019;

Whereas, the Services Selection Board issued the Selection List alongwith Wait list for the aforesaid post in accordance with recruitment rules in vogue and reservation rules applicable to Ex-Serviceman Category and the same was forwarded to the Indenting Department.

Whereas, there is no provision of forwarding the candidate next in order of merit ESM Category due to application of horizontal reservation to the Indenting Department notwithstanding the fact that there is repetition of candidates in the Selection List for two different Medical Colleges. Even otherwise also, after completion of Selection process, Services Selection Board has become functus officio to act further.

Whereas the matter was examined having regard to the aforementioned facts and circumstances, and the Claim of the applicant (to consider him against the Vacant post) was found devoid of any merit.

Now therefore, in view of the above, the claim of applicant, namely Mr. Owais Kamran Nazki, is hereby rejected being devoid of merit.
