Subject: Selection list of candidates for the post of “Store Keeper- cum- Clerk cum Computer Operator, Health and Medical Education Department” (Government Medical College Rajouri) Divisional Cadre, Jammu (Disposal of representation of Mr. Puran Chand Choudhary thereof).

Whereas, an Indent/requisition was received by the Services Selection Board vide Communication No. ME/NG/53/2018-PF dated 11.01.2019, from Health and Medical Education Department for filling up of Non-Gazetted posts of five new Medical Colleges including the Post of Store Keeper- cum- Clerk cum Computer Operator, Health and Medical Education Department” for (Government Medical College Rajouri) Divisional Cadre, Jammu;

Whereas, Jammu and Kashmir Services Selection Board vide Advertisement Notification No. 03 of 2019 dated 01.02.2019 under Item No 033 advertised various posts including the post of “Store Keeper- cum- Clerk cum Computer Operator, Department of Health and Medical Education, (Government Medical College Rajouri), Division Cadre Jammu with the following breakup of Posts:-

OM=29, RBA=11, SC=05, ST=05, OSC=01, ALC=02, Total=53;

Whereas, the prescribed qualification for the aforesaid post as per the Indent received from the Indenting Department is as under:-

“Graduation with certificate course in Computer application from any recognized University/institute.”

Whereas, the Written examination for the aforesaid post was held on 19th May, 2019 and the Provisional Selection List issued by the J&K Services Selection Board vide Communication No SSB/Secy/Sel/2019/4162-67 dated 16.07.2019 and the Counselling/Document Verification was held from 22nd to 26th of July, 2019

Whereas, the Jammu and Kashmir Services Selection Board approved the Selection List for the aforesaid post (GMC Rajouri) and the same was forwarded to the Indenting Department vide Communication No SSB/Secy/Sel/52/J/2019/5436-42 dated 18.10.2019

Whereas, this office is in receipt of representation dated 11.10.2019 submitted by Mr. Puran Chand Choudhary R/o Dhanka, Post Office Chowki, Tehsil Nowshera, District Rajouri wherein he has stated that:-

- i. the Government of Jammu and Kashmir has initiated the process of filling of posts in five newly sanctioned Government Medical Colleges that is Kathua, Doda, Rajouri, Anantnag and Baramulla.
- ii. the Services Selection Board vide advertisement notification no 03 of 2019 dated 01.02.2019 under Item No 033 advertised posts of “Store Keeper- cum- Clerk cum Computer Operator, Health and Medical Education Department” for Government Medical College Rajouri, Division Cadre Jammu.


- iii. three posts were reserved for Ex-Serviceman Category for GMC Rajouri and he had applied for same category for GMC Rajouri pursuant to Advertisement Notice No 03 of 2019 under Item No. 33.
- iv. candidate namely Maroof Hussain S/o Bashir Ahmad R/o Doda applied for the above mentioned posts for GMC Doda as well as GMC Rajouri.
- v. the Services Selection Board issued Provisional Shortlist of candidates vides Notice No. SSB/Secy/Sel/2019/3997-4001 dated 10.07.2019 wherein applicant was figuring at Serial No 4 and Maroof Hussain figured at Serial No. 2 in Ex-Serviceman category.
- vi. thereafter, Services Selection Board issued Final Selection List wherein candidate namely Maroof Hussain selected at two places that is GMC Rajouri as well as GMC Doda and applicant could not find place in Final Selection List of GMC Rajouri.
- vii. applicant Puran Chand Choudhary further stated that Mr. Maroof Hussain who is resident of Doda District will give preference to join in GMC Doda and requested to considered his request and adjust him against the vacant post in the above mentioned circumstances and issue formal order in his favour; and

Whereas, the Services Selection Board issued the Selection List alongwith Wait list for the aforesaid post in accordance with recruitment rules in vogue and reservation rules applicable to Ex-Serviceman Category and the same was forwarded to the Indenting Department.

Whereas, there is no provision of forwarding the candidate next in order of merit under ESM category due to application of horizontal reservation to the Indenting department notwithstanding the fact that there is repetition of candidates in the Selection List for two different Medical Colleges. Even otherwise also, after completion of selection process, Services Selection Board has become functus officio to act further.

Whereas the matter was examined having regard to the aforementioned facts and circumstances, and the claim of the applicant (to consider him against the Vacant post) was found devoid of any merit.

Now therefore, in view of the above, the claim of applicant, namely Mr. Puran Chand Choudhary, is hereby rejected being devoid of merit.
