
ORDER No. 942 SSB of 2020

Subject:- **Cancellation of selection of the candidate for the post of "Jr. Assistant" (Transport Department), Divisional Cadre Kashmir under item No.017 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants .**

- 1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Jr. Assistant" (Transport Department), Divisional Cadre Kashmir under item No.017 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants and recommended the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/M/45/2020/2777-83 dated 28-04-2020 and SSB/Secy/Sel/M/45/2020/3159-65 dated 13-05-2020 for further course of action; and
- 2) Whereas, the selection of the candidate namely **Ajay Dhar S/O Chaman Lal Dhar R/o 105, Sarigufara, Hugam 192401 District Anantnag** figuring at **S.No. 01/OM** was kept withheld subject to validity of Graduation Degree obtained through distance mode in light of Govt. Order No.252-HE of 2012 dated 30-05-2012 and verification of computer course and verification of PRC by concerned DC through RRCM; and
- 3) Whereas, the candidate submitted the Bonafide certificate of Bachelor of Commerce issued by the Registrar, IASE (Deemed to be University), Gandhi Vidya Mandir Sardarshahar Churu vide No.IASE/SRDR/19/Adm/172 Dated 12-12-2019 and ;
- 4) Whereas, as per the Bonafide certificate of Bachelor of Commerce the date of admission was January 2009 and Mode of completion shown is "Distance Mode"; and
- 5) Whereas, the case of the candidate was placed in the 173rd Board meeting and it was decided to cancel the selection of the candidate, considering the ambit and scope of Govt. order No.252-HE of 2012 Dated 30-05-2012.

Now, therefore, in view of the above position, the withheld selection of **Ajay Dhar S/O Chaman Lal Dhar R/o 105, Sarigufara, Hugam 192401 District Anantnag** figuring at **S.No. 01/OM** , for the post of Jr. Assistant" (Transport Department), Divisional Cadre Kashmir under item No.017 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants is hereby CANCELLED abinitio.
