Subject:- **Selection of the candidate for the post of "Jr. Assistant" (PHE/I&FC Department), Divisional Cadre Kashmir under item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants .**

1) Whereas, the J&K Services Selection Board issued the Selection List of the candidate for the post of "Jr. Assistant" (PHE/I&FC Department), Divisional Cadre Kashmir under item No.031 (04 of 2017 dated 28-11-2017) under the Hon'ble Prime Minister's Special Package for Kashmir Migrants and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/M/43/2020/2784-90 dated 28-04-2020 for further course of action; and


3) Whereas, the aforesaid candidate has stated that he has forwarded his Application form proper channel through Director General of Police vide No. Estt/G-37/2017-4186 Dated 16-01-2018 for considering his claim and ;

4) Whereas, after perusal of the record, it was found that the candidate also submitted the advance copy of application form through online system in which against the column; **"are you a employee of State Government"**, the candidate mentioned as **"NO"** and that it has not been countersigned by any authority as is necessary as per the terms and conditions of advertisement notice; and

5) Whereas, it is evident that the candidate has concealed the fact at the time of filling the application form and after getting selected has thought to seek benefit of being "In Service", the case of the candidate was and decided the claim of the above said candidate as In Service candidate has been rejected on the basis of inadvertently filled the advance application form and ;

6) Whereas, the case of the candidate has been examined and found to be benefit of merit;

Now, therefore, in view of the above position, the in-service case of **Vinod Kumar Bhat S/O Jaikrishen Bhat** R/o Logripora Bhat Manzil Aishmuqam 192301, Anantnag, **figuring at S.No. 04/OM** , for the post of "Jr. Assistant" (PHE/I&FC Department), Divisional Cadre Kashmir under item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants is hereby **rejected the claim of his being In-Service Candidate.**
