- 2) The Document Verification Cum Practical test schedule and particulars of the eligible candidates will also be available in the offices of the Administrative Officer, J&K Services selection Board, Jammu /Srinagar.
- 3) All/any additional qualifications/reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained.
- 4) Mere figuring of name in the list does not entitle the candidate to appear in the Document Verification Cum Practical test as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
- 5) No separate call letter shall be issued to any candidate whose name figures in the said list. A candidate who fails to appear in the Practical Test on the given date shall not be entertained later and shall forfeit his/her right of consideration.
- 6) In case of any deficiency with reference to eligibility etc proved at the time of Practical test, the candidate shall not be allowed to appear in the Practical test/document verification, or if any deficiency is found subsequently the candidate shall not be considered for selection and will be treated as disqualified.
