Subject: O.A. No. 061/0031/2020 & M.A. No. 13/2020, titled Neeraj Sharma V/s UT of J&K and others

Whereas, the J&K Services Selection Board vide Advertisement Notification No. 01 of 2019/033, 02/2019/033, 03/2019/033, 04/2019/033 and 05/2019/33 dated 01.02.2019 advertised various posts inter-alia for the post of Storekeeper cum Clerk cum Computer Operator cum Record Clerk cum Coding Clerk, Divisional Cadre Jammu, in Health & Medical Education Department for GMC's Doda, Rajouri, Kathua, Baramulla and Anantnag; and

Whereas, the J&K Services Selection Board conducted the Combined written examination (CBT) for the post of Storekeeper cum Clerk cum Computer Operator cum record clerk cum coding clerk on 19th May 2019 and the Provisional Selection List was issued/notified by the Board vide notification no. SSB/Secy/Sel/2019/4162-67 dated 16.07.2019; and

Whereas the Jammu and Kashmir Services Selection Board vide communication dated 18.10.2019 forwarded the Selection List for the aforementioned post to the Indenting/Administrative Department; and

Whereas, the applicant feeling aggrieved of the aforesaid Selection List approached the Hon'ble Central Administrative Tribunal, Jammu by way of Original Application bearing O.A No. 061/00031/2020 titled Neeraj Sharma v/s UT of J&K and others which was disposed of by the Hon'ble Central Administrative Tribunal, Jammu vide its order dated 15.06.2020 with the following directions:-

"However, the O.A. is disposed with a direction to the respondent no. 2 to decide the representation dated 01.06.2020 (Annexure A-10) filed by the applicant within 7 days from today by way of reasoned and speaking order, with intimation to the applicant by way of email or any other digital/electronic mode on the date of disposal of representation itself. It may be noted that the parties filing the O.A. in the Tribunal have given their electronic/digital address in their pleadings. In any case, the learned AAG for the respondents would inform the concerned respondents about the electronic address of the applicant. Till the afore mentioned representation of the applicant is decided by the respondents, it is directed that one post of Storekeeper cum Clerk be reserved under ALC in any of the GMC's of Doda, Kathua and Rajouri."

Whereas, the case has been examined in light of the aforementioned directions of the Hon'ble Central Administrative Tribunal, Jammu and on the basis of available records; and


Whereas, the applicant has secured 61.00 marks under ALC Category which is much less than the last selected candidate who has secured 65.25 marks and on the contrary, the candidate in the Waiting List at S.No.01 under ALC Category has secured 63.00 marks for the post of Storekeeper cum Clerk in Health and Medical Education Department (GMC Rajouri) Divisional Cadre Jammu pursuant to advertisement/item no. 03/2019/033; and


Whereas, the applicant has secured less marks than the last selected candidate under ALC Category who has secured 63.00 marks and the candidate in the Waiting List under ALC Category secured 61.25 marks for the post of Storekeeper cum Clerk in the Health and Medical Education Department (GMC Doda) Divisional Cadre Jammu pursuant to Advertisement/item no. 04/2019/033; and

Whereas, the applicant has secured much less marks than the last selected candidate under ALC Category who secured 65.25 marks and the candidate in the Waiting List under ALC Category secured 63.00 marks for the post of Storekeeper cum Clerk in Health and Medical Education Department (GMC Kathua) Divisional cadre Jammu pursuant to advertisement/item no. 05/2019/033

Whereas, the matter was placed before the J&K Services Selection Board in its 174th Board meeting held on 16.09.2020 in compliance with the aforesaid directions of the Hon'ble Central Administrative Tribunal, Jammu and as per rules governing the field and it was decided to reject the claim of the petitioner by way of speaking order, being devoid of any merit;

Now, therefore, in deference to the order dated 15.06.2020 passed by the Hon'ble Central Administrative Tribunal, Jammu in O.A No. 31/2020 titled Neeraj Sharma V/s UT of J&K and others and the afore stated facts, the claim of the applicant namely **Neeraj Sharma S/o Karam Chand R/o Naryana, Khour, Jammu** for the Post of Storekeeper cum Clerk under ALC Category Divisional Cadre Jammu in Health and Medical Education Department (GMCs) in pursuance of the Advertisement Notification No. 01 of 2019/03/2019/033, 02/2019/033, 03/2019/033, 04/2019/033, 05/2019/03 dated 01.02.2019 is found without any merit, and hence rejected.
