Subject:- **Cancellation of selection of the candidate for the post of "Laboratory Assistant" (Health and Medical Education Department), Divisional Cadre Kashmir vide item No.161 (04 of 2017 dated 01-12-2017).**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of **"Laboratory Assistant" (Health and Medical Education Department), Divisional Cadre Kashmir vide item No.161 (04 of 2017 dated 01-12-2017)** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/17(M)/2020/3184-90 dated 13-05-2020 for further course of action; and

2) Whereas, the selection of the candidates namely Ranu Sapru D/O Vinod Raina R/O Lane No.23, Block No.139 Flat No.16, Kandoli Nagrota, Migrant Township Jagti Nagar, Jammu figuring at S.No.08/OM and Roop Krishan Bhat S/O Badri Nath Bhat R/O 22 Lane No.17, Jagti Block80, Nagrota, Near Govt Hospital Jammu S.No. 01/OM/Wait were kept withheld and subject to verification/equivalence of 10+2 certificate from the competent authority; and

3) Whereas, the aforesaid candidates have submitted the purported 10+2 marks certificate issued by the Registrar, Jamia Urdu Hind under Roll No.2855 and Registrar, Hindi Sahitya Sammelan Allabdad Uttar Pradesh under Roll NO.6973 respectively ; and

4) Whereas, the Service Selection Board took up the matter with the Secretary, State Board of School Education vide No.SSB/Sel/Secy/17/2020/2975-76 Dated 25-08-2020 regarding verification/genuineness of the purported 10+2 diploma certificate. In response of this office letter, two communications were received from the Secretary, State Board of School Education, Jammu vide No.F(Acad-C) EQ/20/196 Dated 14-09-2020 and F(Acad-C)Eq/20/190 Dated 31-08-2020 respectively, which reveal that the "Jamia Urdu Hind" neither exists in the list of member Boards of Council of Board of School Education in India and nor in the list of other recognized Boards of the Country and the "Hindi Sahitya Sammelan, Allabdad U.P" does not exist in the recognized boards of the country. Moreover, as per Communication of Association of Indian Universities (AIU) New Delhi Vide No.Ev/II(354)2010/369 dated May 18, 2010 the said institute is neither a University nor any University affiliated Institution. It is one of the voluntary institutions SET UP FOR PROMOTION OF HINDI and the conducted by Hindi Sahitya Sammelan are not equated with the regular examination of Secondary Board/Universities as equivalent to class 10th/12th examination; and

5) Whereas, the case of the candidates were placed in the 175th Board meeting of the Services Selection Board it was decided to cancel the selection of the candidates in light of clarification received from the Secretary, State Board of School Education, Jammu.




