Subject:- **Cancellation of selection of the candidate for the post of "Statistical Assistant" (Planning & Development Department), Divisional Cadre Kashmir under item No.153 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants .**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Statistical Assistant" (Planning & Development Department), Divisional Cadre Kashmir under item No.153 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants and recommended the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/M/71/2019/3254-60 dated 22-05-2019 for further course of action; and


2) Whereas, the selection of the candidate namely **Arti Bhan S/O Man Mohan Bhan R/o H.No.44, Lane No.02, Laxmi Vihar Near Raghav Resort Jammu figuring at S.No. 52/OM** was deferred for want of certain clarification from Higher Education Department; and

3) Whereas, as per the Bonafide certificate of Master of Computer Application the date of admission was August 2006 and Mode of completion shown is "Distance Mode"; and

4) Whereas, the Board took up the matter with the Secretary to Government, Higher Education Department, Civil Secretariat Sringar vide No.SSB/Secy/Sel/71/2019/4186 Dated 17-07-2019 regarding clarification whether the qualification of MCA in distance mode can be considered for the purpose of public employment in light of Govt. Order No.252-HE of 2012 dated 30-05-2012 or otherwise and whether the degrees obtained through lateral entry in distance mode in technical courses like MCA are to be considered at par with courses completed through regular mode. In response of this office letter a reference was received from the concerned Department vide No.HED/Gen/60/2019 Dated 11-12-2019, which mentioned that the Government Order No.252-HE of 2012 dated 30-05-2012 regarding the Validity of Degrees obtained through Distance of Mode of Education issued by the Higher Education Department is self explanatory and you can take further necessary action at your own level; and

5) Whereas, the case of the candidate was placed in the 175th Board meeting and it was decided to cancel the selection of the candidate, after taking into account the parameters laid down in the Govt. order No.252-HE of 2012 Dated 30-05-2012.

Now, therefore, in view of the above position, the withheld selection of **Arti Bhan S/O Man Mohan Bhan R/o H.No.44, Lane No.02, Laxmi Vihar Near Raghav Resort Jammu figuring at S.No. 52/OM** , for the post of "Statistical Assistant" (Planning & Development Department), Divisional Cadre Kashmir under item No.153 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants is hereby CANCELLED abinitio.
