Subject:- **Cancellation of selection of the candidate for the post of "Jr. Assistant" (Finance Department), Divisional Cadre Kashmir vide item No.156 ( 04 of 2017) dated 01-12-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants .**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of "**Jr. Assistant" (Finance Department), Divisional Cadre Kashmir vide item No.156 ( 04 of 2017) dated 01-12-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants** and recommended the same to the Intending Department vide communications No. SSB/Secy/M/40/2020/2854-60 dated 29-04-2020 for further course of action; and

2) Whereas, the selection of the candidate namely **Amit Revoo S/O Pran Nath Revoo R/O H.No.29, Lane No.02, Revoo Niwas, Sector B/1 Laxmipuram, Shobha Model Hr. Sec. School Jammu Chinore figuring at S.No. 11/OM** was kept withheld subject to validity of BBA Degree obtained through distance mode in light of Govt. Order No.252-HE of 2012 dated 30-05-2012 of Higher Education Department, and verification of PRC by concerned DC through RRCM; and


3) Whereas, the candidate has submitted the Bonafide certificate of Bachelor of Business Administration (BBA) issued by the Director of Distance Education, Sam Higginbottom University of Agriculture Technology and Sciences; and

4) Whereas, as per the Bonafide certificate of Bachelor of Business Administration (BBA) the date of admission was May 2013 and Mode of completion "Distance Mode"; and

5) Whereas, the case of the candidate was placed in the 175th Board meeting and it was decided to cancel the selection of the candidate, after taking into account the parameters laid down in the Govt. order No.252-HE of 2012 Dated 30-05-2012.

Now, therefore, in view of the above position, the withheld selection of **Amit Revoo S/O Pran Nath Revoo R/O H.No.29, Lane No.02, Revoo Niwas, Sector B/1 Laxmipuram, Shobha Model Hr. Sec. School Jammu Chinore figuring at S.No. 11/OM "Jr. Assistant" (Finance Department), Divisional Cadre Kashmir vide item No.156 ( 04 of 2017) dated 01-12-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants** is hereby CANCELLED abinitio.
