The matter related to the candidates possessing qualifications/degrees from Rashtriya Sanaskrit Sanasthan and falling with in the selection zone was placed before the Board in the 27th Board meeting. After threadbare discussion, it was decided that a clarification in the matter is required to be sought from the Indenting Department / Jammu University / JKBoSE.

Further, after deduction of points on the basis of the undertaking/ affidavit submitted by the four candidates (placed on C/F side), following position emerges:-

Anil Kumar (Roll No. 107058275, Int. S.No. 128, Blank slot at S.No. 84-RBA, item No. 478 (05 of 2013)): After deduction of 5 points, the candidate still remain within the selection zone of same item No. viz. 478 (05 of 2013) at S.No. 144 under RBA category with revised merit 41.5468.

Naresh Kumar (Roll No. 107066237, Int. S.No. 1012, Blank slot at S.No. 71-RBA, item No. 478 (05 of 2013)): After deduction of 7 points, the candidate moves out of the selection zone of Item No. 478 (05 of 2013) and will enter in the selection zone of Item No. 470 (06 of 2013) under RBA category at S.No. 22 with revised merit 40.5618.

Ashwani Sharma (Roll No. 107059890, Int. S.No. 289, Blank slot at S.No. 131-RBA, item No. 478 (05 of 2013)): After deduction of 5 points, the candidate moves out of the selection zone of Item No. 478 (05 of 2013) and will enter in the selection zone of item No. 470 (06 of 2013) under RBA category at S.No. 78 with revised merit 37.3558, where a slot for the purpose was kept.

Consequent upon the situation summed up herein above, following change in the serial positions will take place.

Under RBA Category of Item No. 478(05 of 2013), S.No. 72 will now become 71, S.No. 73 will now become 72 so on and so forth uptill S.No.83 now becoming 82 and S.No. 85 will now become 83, S.No. 86 will now become S.No. 84 so on and so forth uptill S.No. 147 now becoming S.No. 146. Thereby, creating a vacancy at S.No. 147. The candidate namely Pooja Sharma (Roll No. 107068667, Int. S.No. 1274) who was selected in item No. 470(06 of 2013) at RBA-12 with merit position 41.2771 will now enter into the selection zone of item No. 478(05 of 2013) under RBA Category at S.No. 147.

Under RBA Category of Item No. 470(06 of 2013), S.No. 13 will now become S.No. 12, S.No. 14 will now become S.No. 13 so on and so forth until S.No. 22 will now becoming S.No.21, paving slot for Mr. Naresh Kumar (Roll No. 107066237, Int. S.No. 1012) at RBA S.No. 22.

The requisite annexures are placed on C/F side of the file.

Furthermore, on deducting the PG points (as requested by the candidate) from the over all merit of Mr. Suresh Kumar (Roll No. 107076582, Int. S.No. 1448) figuring at S.No. 9 under SC Category of item No. 478(05 of 2013), the candidate will still remain within the selection zone of same item No. at S.No. 35-SC with revised merit 60.7715. Consequently, S.No. 10 will become S.No. 9, S.No. 11 will now become S.No. 10 so on and so forth. Since, some more cases related to consideration/non consideration of certain degrees of some candidates are yet to be settled, hence, the merit serial position may get changed.
