The candidate whose particulars are given below are hereby informed that their interview for the post of

Shall be conducted as per the schedule containing Date/Venue and full particulars of the candidate indicated at Annexure "A" of this notice. The candidate were earlier not short listed, however, on motion of representations by the candidate for considering them; the claim has been found genuine and are accordingly being called for interview.

1. The interview schedule and particulars of the eligible candidates will also be available in the offices of the Administrative Officer, J&K Services selection Board, Jammu /Srinagar.
2. The additional qualifications / reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained;
3. Mere figuring of name in the list does not entitle the candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
4. No further interview call letter shall be issued to any candidate whose names figure in the said list and they are required to appear before the interview committee on the schedule date & time. Failure of a candidate for appearing in the interview on the given date shall not be interviewed later and shall forfeit his/her right of consideration
5. In case of any deficiency with reference to eligibility etc proved at the time of interview, the candidate shall not be allowed to appear in the interview, or if any deficiency is found subsequently the candidate shall not be considered for selection and will be treated as disqualified.
6. The candidate shall have to produce all original certificates / testimonials as asked for vide above referred advertisement notification before the interview committee at the time of interview. The candidates who fail to produce such certificates / testimonials may forfeit their candidature.
7. Any candidate found guilty of impersonating or submitting fabricated / tampered documents / testimonials or making false, incorrect or suppressing material information shall render him / her liable for criminal prosecution under law and may be debarred permanently or for a specific period for consideration of any or all recruitments made by the Board. Also canvassing / lobbying in any form will entail disqualification of the candidate.
8. Moreover, candidates appearing in the interview shall submit an undertaking to the effect that they have not appeared in the interview for the same post against same Item/Notification earlier.
9. No TA/DA shall be paid for participation in the interview.

Note:-(1) The candidate who are already in service and have submitted their application form as in service candidate, shall produce the valid documents issued by the Head of Department as per the contents of the respective Advertisement Notifications at the time of interview.

(2)The candidates are advised to bring Photostat copy of each certificate duly attested by Gazetted Officer/ self attested by the candidate himself should be brought along for depositing with the Board on the scheduled date and time of interview in addition to original documents, failing which no claim / objection in this regard shall be entertained.

(3) Failure of a candidate for appearing in the interview on the given date shall not be interviewed later and shall forfeit his/her right of consideration.
