Whereas, with reference to aforementioned letter Skill Development Department vide their letter No.Edu/Tech/poly/41/2018 dated: 22-06-2020 intimated that the matter was taken up with the University of Kashmir. The operative part of the letter of Kashmir University bearing No.F(Clarification-PGTM) Accad/KU/19 dated: March 07, 2019 reads as under:-

**Post Graduate degree in "tourism Management" is appropriate degree and in tune with the advertisement made by J&K Service Selection Board for the position of Demonstrator (Travel & Tourism). However, the eligibility would be subject to having secured not less than 50% marks**
