Whereas, the Hon'ble High Court vide its Order dated 08.03.2018 disposed of the aforesaid Writ petition with the following directions:-


"Relief of quashment cannot be granted on a mere plea that the petitioner appeared before the Services Selection Board, however, the petitioner's grievance is that he did appear for interview and signed the attendance sheet. Since the record is available with the Services Selection Board, the petitioner is permitted to appear in person or through his counsel before the Services Selection Board and seeks clarification with regard to his participation in viva voce and stakes his claim on merits for the purpose of appointment to the said post if the record is in his favour and if the rules permit at this stage. It is made clear that there is no interim order passed at any point of time restraining the Service Selection Board from proceeding with the selection.

Keeping that in mind, the Service Selection Board-Respondent No.s 2 & 3 shall give an opportunity to the petitioner or his counsel to verify the record as above and thereafter, decide the matter on its own merits in accordance with law. If the petitioner is still aggrieved, he can work out his remedy as per law. The writ petition along with connected MP, if any stands disposed of in the above terms."

Whereas, in compliance with the order dated 08.03.2018 passed by the Hon'ble High Court, Jammu, a notice bearing No. SSB/Legal/M-18/09/769-71 dated 19.07.2019 was served upon you to present yourself before the Secretary, JKSSB, Zum Zum Building, Rambagh, Srinagar on 23<sup>rd</sup> July, 2019 at 11.00 AM in person or through your counsel for clarification and verifying records, so that the matter is taken to its logical conclusion. However, in response to the said notice you did not cause appearance before the Secretary, Services Selection Board and that nothing has also being heard from your side till date.

Accordingly, you are once again informed by way of this notice to present yourself before the Secretary, JKSSB, Hema Complex, Sector-03, Channi Himmat, Jammu within a period of 07 (Seven) days from the date of publication of this notice in person or through Counsel for clarification and verifying of records, so that the matter is taken to its logical conclusion.
