The following lines shall be deemed as added/inserted at S.No.6 of the Note of Annexure "A" in respect of the posts of Sainik Welfare Department, J&K Advertised in Notification No.06 of 2020 Dated:29-12-2020:

The upper age limit for Ex-Serviceman candidates who apply against the posts of Sainik Welfare Department, J&K shall governed by Rule 6 of the Recruitment Rules, notified vide SRO 59 of 2019 dated:-18th January 2019, issued by the Home Department which reads as under:-

No person who is less than 34 years or more than 52 years of age on the 1st day of January of the year in which applications are invited, shall be eligible for appointment to any post in the services by direct recruitment.

Provided that the minimum age limit shall not be applicable to the Ex-Servicemen who have 50% or more disability attributable/aggravated to military service and who are in receipt of disability pension for re-employment in Sainik Welfare Department.

Other terms & Conditions shall remain unchanged.
