The documents verification/scrutiny conducted by the Board is limited to the extend of establishing physical possession of category/degree certificates in

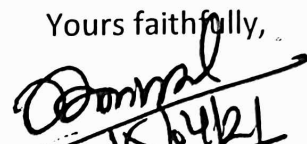


reference of advertised notification and establishing the relevance /genuineness/validity of otherwise of the same shall be responsibility of the appointing authority.
